This past weekend an establishment in District 9, Retox Martini Lounge, hosted an entirely unmasked event that did not adhere to social distancing mandates. A video of the event can be found here: www.facebook.com/tworealfrom.abm/posts/4197685950245002

As librarians in District 9 and residents of Milwaukee, we are writing to express our concern. As you know, many libraries on the Northwest side in Milwaukee County are currently closed to the public for in-person services due to high COVID-19 positivity and hospitalization rates. For the past three weeks, library patrons have been unable to access the services that many need most, specifically computer access, printing, scanning and faxing.

Since the outbreak of the pandemic and the closing of libraries in March, we have, personally, made sure to behave responsibly in order to guard our own and our households' personal safety. When libraries opened to the public, we took even more extreme steps to ensure that we had contact with virtually no one outside of our own households in order to ensure maximum safety for the patrons entering the library to take care of their information needs, whether that involved borrowing material, help with a reference question, or using the computer to fill out employment and/or housing-related paperwork as a result of the pandemic.

Parties such as the one that occurred over the weekend are not just disheartening, they're dangerous. These are potential super spreader events, and it's not a farfetched notion to imagine that at the very least, family members within the same household as some of the attendees, if not the attendees themselves, would likely be patronizing libraries and businesses in and around your district.

While we don't know what can be done to prevent similar events going forward, we did want to let you know of our concerns, and to thank you for all you have done and continue to do to keep Milwaukee safe and running as we wait for the joyful day when we are able to fully and safely gather in public.

On June 27th at 1:44am, Brown Deer PD was dispatched to Walmart for a shooting. Upon their arrival, they were told by patrons of Retox, there was a shooting. Brown Deer called MPD and then proceeded to go to retox, to assist in the investigation. Brown Deer PD was the first to arrive on scene at which time, they were given a hard time about entering the bar. They were able to enter and conduct a quick safety search (Make sure no on inside was shot) then escorted out of the building. MPD arrived and they refused entry. There was a long investigation conducted by our department. There were several casings recovered from the parking lot.

We held a meeting here at D4 on 7/10 with us, Brown Deer PD, LIU and the ACA's office. They stated they would send a calendar of events and hire more security.

The are in the process of repairing their camera system that was not working when this incident occurred.

Bottom line is they are hosting large events and when things get out of hand, they claim not to have any knowledge of the incidents. We have not received any calendar of events as of yet. But aware they are occurring.

This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/27/2018 at 12:15pm officers, along with Agent William GRAY from the WI Department of Revenue, conducted a license premise check at 6901 W. Brown Deer Rd. The officer found the sole employee, Cheree PERRYMAN, in the kitchen area. The officers observed the establishments licenses were not posted and found several items for smoking Hookah. The officers observed several open containers of liquor with a large funnel next to them. They also observed several boxes of liquor with labels from Express Liquor Store. The applicant arrived on scene and stated she has not displayed he licenses. Her son, Larry WILLIAMS, could not find invoices for the liquor and stated he has bought liquor from the store on occasion because the distributor was closed or has a poor selection. He stated he did not know this was illegal. The officers seized 271 bottles of liquor and a package of hookah tobacco. The applicant was issued citations for not having a bartender on the premise and failure to display licenses.

2. On 06/27/2020 at 1:44am officers were dispatched to 6901 W. Brown Deer Rd for a possible shots fired complaint. The officer met Brown Deer Police, who had been dispatched to Wal-Mart at 6300 W. Brown Deer Rd. When they arrived at Wal-Mart, witnesses stated there was a shooting at Retox Martini Lounge. Brown Deer Police responded to that location and observed numerous cars fleeing the parking lot. They spoke with the bartender, who stated there was no problem and they would need a warrant to look around. Milwaukee Police Department officers searched the parking lot and found 11 casings. The officers spoke with a citizen, who stated her nephew was shot in the leg but they were unable to locate a victim.

- 3. On 07/10/2020 a meeting was held at District Four regarding the shooting at Retox on 06/27/2020. The officer asked the applicant why the officers were denied entry. The applicant's son, Larry WILLIAMS, stated he did not deny Milwaukee Police Department access but did tell the Brown Deer Police that they did not have jurisdiction. WILLIAMS stated they have ID Scanners, wands, and security. He stated the cameras are not working because of water damage. The applicant stated she will work with the police because she wants a safe establishment. She stated she would invest in parking lot security and have the cameras fixed soon.
- 4. On 10/30/2020 at 9:21pm officers conducted a license premise check at Retox Martini Lounge, 6901 W. Brown Deer Rd. The officers observed security staff patrolling the parking lot as well as the interior of the building. They spoke with the manager, Larry WILLIAMS, who presented his plan that was approved by the Health Department for safe operation. He stated the dance floor would be closed off and all patrons wearing masks. At 1:26am the officers returned and saw security in the parking lot directing traffic to assist vehicles exiting in a timely manner. The officers did not observe any violations.
- 5. On 11/30/2020 at 12:53am officers were dispatched to a shots fired at 6901 W. Brown Deer Rd. The officers spoke with Larry WILLIAMs, who stated he is the owner's son. He stated there was a fight in the main bar area but no shots were fired. He stated it's hard to pull up the security footage so he would only show the officers the video if they found casings. The officers spoke with a caller, who stated she heard 7-8 shots but was not sure if they were inside or outside. The officers did not locate any victims or evidence of shots fired.
- 6. On 12/20/2020 at 1:27am officers were dispatched to Retox Martini Lounge, 6901 W. Brown Deer Rd for a Call for Police. The officers observed several groups of people fighting in the parking lot. The officers were able to break up the fights. The officers and security were able to eventually clear the parking lot. The manager was on scene and cooperative.
- 7. On 12/30/2020 at 7:41pm officers conducted a license premise check at Retox Martini Lounge, 6901 W. Brown Deer Rd. The officers spoke with Larry WILLIAMS, who is operating the bar. The officer stated he wanted to speak with security about the procedures they are using at the business. WILLIAMS stated he was hiring a new company and he would rotate the guards to different spots to prevent them from becoming comfortable in one spot. He also stated he has ordered a new camera system. He stated there have been incidents in the parking lot and across the street at Aldi and Wal-Mart, but not inside his business. WILLIAMS also stated that he has security in the parking lot, which has helped keep car break-ins down. He also believes his business is being blamed for issues in the surrounding area.

8. On 01/02/2021 at 2:06am officers were dispatched to an Active shooter at Retox Martini Lounge, 6901 W. Brown Deer Rd. The officers cleared the business but found no evidence of an active shooter or any shots being fired. The officers spoke with Larry WILLIAMs, who stated he is the owner's son. He said there were no shots fired and thinks someone called from the parking lot.

#### INITIAL INVESTIGATION

On Saturday June 27, 2020 at approximately 1:44am P.O. Shirley THOMAS-BALDWIN and I were dispatched to 6901 W. Brown Deer Rd, which is located in the city and county of Milwaukee, to meet with Brown Deer police who were on scene of a possible shots fired.

#### **INITIAL OBSERVATIONS:**

Upon arrival I observed there were 3 Brown Deer Police Department squads parked blocking 2 of the 3 entrance/exits to the parking lot of a strip mall. There were several businesses inside the strip mall, including the dispatched location of RETOX Martini Lounge. I observed numerous orange traffic cones strewn about the parking lot of the mall as well as various items of liter, including broken beer/liquor bottles. Broken glass covered several areas of the parking lot. All of the businesses appeared closed, including the dispatched location. There were approximately 6 vehicles still parked in the lot, I later identified the registered owners of those vehicles.

#### INITIAL CONTACT:

We met with Brown Deer Officers: WANDAOGO, WHITE, STAAT, and BARTOSIK. STAAT stated that Brown Deer responded to a shots fired at their Wal-Mart, 6300 W. Brown Deer Rd at approximately 1:37am. Upon arrival they met with a person who they did not identify who stated that there was a shooting at Retox Martini Lounge, 6901 W. Brown Deer Rd. This person then left the scene.

Brown Deer Police proceeded to 6901 W. Brown Deer Rd., and observed numerous vehicles and patrons fleeing the parking lot and bar of RETOX. They entered the premises and asked what had happened and the B/M Bartender told them nothing happened and that they needed a warrant if they wanted to look for anything. He then told them they needed to leave. STAAT also stated that Bayside Police had stopped a vehicle driving at a high rate of speed east bound on W. Brown Deer Rd., and the driver had told them they were present during the shots being fired at this location. This person was later arrested on suspicion of first offense operating while intoxicated.

STAAT stated that an unidentified B/F then approached them and stated that her nephew, Zaire S. DALTON, B/M 11-06-1998 had been shot in the knee at this location. She was at the location attempting to locate him.

#### **INVESTIGATION:**

I notified Sgt. Mathew GADZLINSKI of this information and he responded to the scene. We conducted a check of the parking lot and located 11 casings and one unspent .762 rifle round. We also located a significant amount of blood in the parking lot directly in front of the main entrance to the bar. The blood appeared to be a deep red color and there was enough on scene to indicate a possible serious injury had occurred at this location.

I then spoke with Bayside Police Lt. Paul PICCIOLO and P.O. David BUNTING who stated they stopped Joneah L. PETERSON, B/F 07-15-1994 who was fleeing the area at a high rate of speed. PETERSON also had a passenger in her vehicle, Khaleelah WILKERSON, B/F 03-26-1999. PICCIOLO and BUNTING stated that PETERSON and WILKERSON told them they were at RETOX drinking for approximately one hour when they heard gunfire and ran from the building. At one point PETERSON fell down and cut both of her knees open, which required medical attention during her encounter with Bayside Police. Bayside PD had released PETERSON and WILKERSON prior to my contact to Jayla T. DUTSON, F/B 09-11-1998, after citing PETERSON for 1st offense OWI. Neither WILKERSON or PETERSON had stated they had seen anyone that had been struck by the gunfire.

#### **EVIDENCE:**

Forensic Investigator CERVERA responded to the scene and collected the evidence and photographed the scene. See supplement regarding.

Cameras were located in front of 6801 W. Brown Deer Rd., in front of Tobacco and Vape and the US Post Office, located at 6825 W. Brown Deer Rd. Follow up is required to attempt to collect video footage from these locations and the dispatched location.

#### **FOLLOW UP:**

A licensed premise report will be completed regarding contact with RETOX by Brown Deer Police.

P.O. THOMAS-BALDWIN made contact with one of the listed bar owners, Joyce M. HILL, 03-02-1953 who on initial contact stated she was unaware of any shooting having occurred at the location but said she had been at the bar. She stated that she would contact the other listed person, Larry B. WILLIAMS, B/M 06-29-1975 who was working that night. THOMAS-BALDWIN spoke with HILL a second time and stated she was at the bar until approximately 10pm but then left. She was unaware of any shooting and she was now out of town and unable to respond to the location to allow us to view video footage of any incident. She also stated that she had been unable to reach WILLIAMS by phone and that his phone was disconnected. HILL was mostly uncooperative and evasive when answering questions regarding the nights events.

CIB responded to this incident and took over the investigation.

10:00 am the following persons attended a meeting at District Four. LT. Shannon Taylor, LT. Ann Koepel (Brown Deer Police Dpeartment), P.O. Carrie Resnick, P.O. Tracey Geniesse, ACA Heather Hough, Joyce Hill (Licencee for Retox), India Holland (Bartender), Larry Williams (Son of Ms. Hill). The purpose for this meeting was regarding case number 201790021, shooting complaint on 6/27/20.

Lt. Taylor began the discussion stating, Brown Deer Police were dispatched to a shooting complaint at Walmart at 6300 W Brown Deer Rd located in Brown Deer, WI. Upon their arrival, Brown Deer Officers were notified by the caller, the shooting occurred at Retox lounge at 6901 W Brown Deer Rd in the City of Milwaukee. Brown Deer PD then called Milwaukee PD to notify us of the incident. (All info is on the previous PA-33) Lt. Taylor asked about Officers not being able to enter the premise after Brown Deer officers were asked to leave. Larry Williams stated, he never denied entry to MPD, they never attempted to enter the location. Williams stated, he even offered the Detectives entry, but they declined. Williams stated he was unaware that anything or shots fired took place. He stated no one brought this incident to his attention until Brown Deer PD arrived on scene. He stated they were closing between 1:15 AM and 1:30 AM and four Brown Deer Officers pushed their way into the bar. He stated he advised them, they are not MPD officers and don't have jurisdiction in Milwaukee. They conducted a protective sweep acting as a Community care taker and exited the building after a search.

Lt. Taylor asked what measures are currently in place, Mr. Williams stated he has it all, wanding patrons, Id Scanner and security. Cameras are currently not working due to water damage. Ms. Hill stated she will invest in parking lot security and have new security cameras soon. She stated we are barely open right now due to Covid-19 but there was an event on this night. She wants to have a safe business in the community. She will work with District Four in the future and keep an open line of communication.

ACA Hough stated the importance of calling the Police when an incident occurs at the establishment, because each PA-33 is read at the license renewal hearings, for example, this meeting will be filed on a PA-33 as well, so not all of them are a bad report.

Lt. Taylor asked how do they advertise? Mr. Williams stated he does not use promoters. He stated they have private events such as birthday parties, etc.

Ms. Hill stated she will work with the Milwaukee Police Department in the future, keeping an open line of communication. Ms. Hill agreed to send a calendar of events to District Four.

## NATURE OF CALL/ JUSTIFICATION

On Friday, October 30, 2020 at approximately 9:21 pm, PO Khalid MAJEED and I (Squad 4467) conducted a Tavern Check at Retox Martini Lounge which is located at 6901 W Brown Deer Rd. This address is located in the City and County of Milwaukee, WI.

## INITIAL OBSERVATION

The Retox Martini Lounge is apart of a connected strip mall on the south side of W Brown Deer Rd. The main entrance and exterior walls of the business is constructed from full glass. The business has security cameras mounted on the exterior and interior of the location. The business has a security staff which patrol the exterior parking lot as well as securing the interior of the location. The hours of operation was posted in plain view on the main entrance of the building.

The interior of the business is separated in to two section by a dividing door which can be opened at anytime by the management. The main section of the business contained a bar and seating area. The second section of the business contained a dance floor and also a stand alone bar.

#### INVESTIGATION

On this same day, Squad 4467 was informed that the business was holding a concert inside of the premise. The main act for the concert was Rahkeib D. SMITH (B/M 04/06/1995) with the stage name of "Lil Chicken". SMITH has an active felony warrant for possessing a firearm by a felon. (Warrant #K01199)

PO MAJEED and I arrived at the mentioned address at approximately 9:25 pm where we observed approximately 10 vehicles in the parking lot in front of the location. We observed a member of the security staff placing cones in front of parking spots directly in front of the business to block off certain areas of the parking lot to prevent traffic flow for safety reasons. We were met by the acting manager, Larry B. WILLIAMS (B/M 06/29/1975) at the main entrance of the business. WILLIAMS granted PO MAJEED and I access into the building where we walked through the building with him. WILLIAMS inquired about the Safety Plan required by the City of Milwaukee due to Covid 19 restriction and provided us documentation of the business receiving

approval for their submitted Safety Plan. WILLIAMS stated that the dance floor inside of the location will be closed off for dancing purposes and everyone inside of the building will have on a face covering or mask.

PO MAJEED and I observed workers inside of the location preparing for the evenings activities but did not locate SMITH inside nor outside of the building. I asked WILLIAMS what type of performance was being held at the location and he informed me that "Lil Chicken and Loonie Baby" will be one of the acts performing at the location. WILLIAMS stated that SMITH was known to not show up for his scheduled shows but believe that he would be at the location later this evening. PO MAJEED and I did not inform WILLIAMS of SMITH active warrants as he may have alerted WILLIAMS of the police presence prior to him arriving. WILLIAMS informed officers that we were always welcomed inside of the business and was willing to cooperate with police if needed. PO MAJEED and I informed WILLIAMS that we would return later this evening to assist with monitoring the event activities.

At 1:26 am, PO MAJEED and I returned to the business where we observed that the entire parking lot was filled with vehicles. We observed mobile security guards in vehicles posted at all of the driveways leading into the parking lot. Each of the security vehicles were equipped with strobe lights which was activated.

PO MAJEED and I exited our vehicle and approached the main entrance of the business where we observed security guards posted inside and outside of the location. PO MAJEED and I were informed that SMITH departed the scene prior to officers arrival. At approximately 1:40 am, an announcement was made inside of the business that the bar was closed and everyone needed to return to their vehicles and leave. PO MAJEED and I stood by and monitored the closing time activities of the business where security actively escorted patrons out of the building and directed them to their vehicles. PO MAJEED and I observed that the mobile security guards directed traffic in the parking lot and assisted the vehicles to exit the lot in a timely manor.

Once all the patrons were out of the business, PO MAIEED and I walked through the building and did not locate SMITH. I did not observe SMITH amongst the crowd of individuals leaving the business during bar closing time. I did not observe any issues inside nor outside of the business during this investigation.

Upon arrival officers observed most of the bar patrons leaving the bar in their vehicles. Approximately (10) vehicles were still at the bar when officers entered the bar. Officers cleared the bar and did not locate any victims, casings, or evidence of shots being fired.

Inside the location I spoke to Larry B. WILLIAMS (b/m, 6-29-1975) who stated he is the owners son. WILLIAMS stated there was a fight that occurred in the main bar while he was in the side bar area. WILLIAMS stated some guy was getting jumped and everyone freaked out. WILLIAMS stated there were no shots fired inside the place of business. WILLIAMS stated he would only show officers security surveillance, if officers located any casings. WILLIAMS stated it was too much work to pull up security surveillance if there was no reason to.

I spoke to the bar manage Indea D. HOLLAND (b/f, 1-3-1988) stated she was in the back room, when she heard something going on in the main bar. HOLLAND stated she did not hear any gun shots. HOLLANDS stated she had no access to the security surveillance and believes only the owner has access to them.

I called the callers and spoke to two of them. Colleen, 414-759-1141) stated a fight broke out inside the bar. Colleen stated she believed she heard approximately 7-8 gun shots, but was unsure if the shots

#### **INITIAL INVESTIGATION**

This report is written by P.O. Khalid MAJEED assigned to District #4, Late Power Shift. On Wednesday, December 30, 2020, I, assigned to Squad 4467, conducted a "Tavern Check" at 6901 W. Brown Deer Rd. (Retox Martini Lounge). This is located in the City and County of Milwaukee.

Upon my arrival, I spoke with Larry B. WILLIAMS (b/m, 06-29-75) who is the licencee person involved for this establishment. It should be noted that the establishment was not open operating as a bar or lounge at the time and WILLIAMS stated he was just closing the businesses restaurant for the day. I notified WILLIAMS that I wanted to speak with his hired security company about their tactics, i.e. searching, patrolling, etc. I also urged WILLIAMS to speak with his security and to watch closely to make sure they are not allowing people into his establishment with weapons. WILLIAMS stated that he will because he does not want weapons inside of his business and that he is hiring a new security company. WILLIAMS stated he will rotate security guards around the club into different spots randomly so the guards can't get comfortable. WILLIAMS also stated that police has responded to the location for shots fired calls but stated there has not been any shots fired inside of his club.

WILLIAMS stated there has been incidents outside in the parking lot, across the street at Aldis, and down W. Brown Deer Rd. at Wal Mart, but stated his place of business doesn't have any problems and that police are welcome to come inside anytime they want.

WILLIAMS stated he has ordered a new camera system that will surveillance the establishment better inside and out and it should be arriving soon. WILLIAMS stated regarding car break ins, it has not been too bad because he also has lot security. WILLIAMS stated he did notice a suspicious red mini van with approximately 6 men inside that kept circling the parking lot at the location recently but they did not break in any vehicles.

WILLIAMS stated he has cancelled the New Years Eve party at this location that was scheduled for Thursday, December 31, 2020, but plans on having the bar open on New Years Day 2021.

WILLIAMS appeared to be irritated because he feels as if surrounding issues are being blamed on his establishment. WILLIAMS stated he is looking to set up a meeting with the alderman regarding. I gave WILLIAMS a MPD Community Contact Card regarding.


