Publication of the Public Hearing Notice in the Newspaper

Dear Alderman Hines:

In accordance with Chapter 18 of the City Charter, the joint public hearing on the budget must be held on or before October 20, but not less than ten days after the publication of the proposed budget summary in the newspaper. A further statutory and charter requirement states that the joint public hearing shall not be held less than seven days after the last date of publication of the notice of the hearing in the newspaper.

Based on the scheduled date of October 12 for the joint public hearing, we are planning to publish the proposed budget summary in the *Milwaukee Journal Sentinel* on Thursday, October 1, 2009. Publication on this date will meet the charter and statutory requirements.

You and the City Clerk may wish to authorize this office to publish the public hearing notice in the newspaper on October 1, along with the proposed budget summary.
