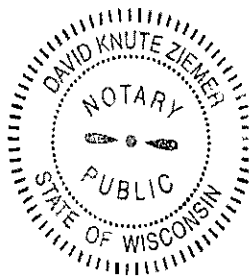

A substitute ordinance to establish a Development Incentive Zone on land located generally along the East side of South 27th Street between West Howard Avenue and West Loomis Road, in the 13th Aldermanic District.

**100262**

A substitute ordinance establishing a pedestrian mall to be known as "Erie Street Plaza" in East Erie Street, adjacent to the harbor entrance, in the 4th Aldermanic District.

**100618**

A substitute ordinance to further amend the 2011 rates of pay of offices and positions in the City Service.

**100766**

A substitute ordinance relating to the Second Amendment to a Detailed Planned Development known as RGS Warehouse, to allow for site plan modifications, on lands located on the west side of South 6th Street and north of West College Avenue, in the 13th Aldermanic District.

**100768**

A substitute ordinance relating to a change in zoning from Industrial Light to Industrial Heavy to facilitate industrial expansion of Integrated Mail, Inc., on land located north of West Hopkins Street and east of North 35th Street, in the 1st Aldermanic District.

A substitute ordinance to further amend the 2011 offices and positions in the City Service.

A charter ordinance relating to state reporting by the employees' retirement system.

A substitute ordinance relating to parking controls.
