(2) The zoning map is amended to change the zoning for the area described and bounded by 522 East Pleasant Street, Tax Key No. 360-0064-000, and 1601 North Jackson Street, Tax Key No. 360-0063-100, from Local Business (LB2) to Detailed Planned Development (DPD).

(3) The requirements set forth in said detailed plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for

common Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the effect of the approval of such detailed plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in such detailed plan.
