I observed the rear registration plate had March and 2014 stickers affixed to the plate. I checked with DOT and the vehicle registration came back expired since March of 2013. The owner and permit holder of the vehicle is Victor CAMARILLO-ROSALES, W/M, 11-24-63, of 2201 S. 15th St. I was unable to contact CAMARILLO-ROSALES. I notified P.O. Mary SIKORA at the License Division regarding the violations. P.O. SIKORA contacted the license division and verified that Camarillo taxi permit #24 was revoked since February 2013 for a taxicab meter violation.
