Part 1 There is added to the Mil-waukee Code of Ordinances ("Code") a new section to read as follows:

Section 295-907/2/aj,0034

(I) in accordance with the provisions of Section 295-907 of the Code relating to the establishment of planned development districts, the Common Council approves the subject General Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the CIV Clerk and made a part as though fully set forth berein.

(2) The zoning map is amended to change the zoning for the area described and bounded by the zoning line within South Water Street, the zoning line within Fast Pittsburgh Avenue/North Brackway the zoning line within the Milwaukee River, and the zoning line within the Milwaukee River, and the

Planned Development (GPD).

(3) The requirements set forth in said general plan attached to this Common Council file as Exhibit A, constitute the zoning regulations for the area contrained in such planned development district described, provided further, that the effect of the approval of such general plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the general plan to all conditions and limitations set forth in such general plan.
