Dear Sir:

I have received your letter dated July 16th and am amazed by the findings of your Investigator Adjuster, Mr Robert M. Overholt. Obviously, Mr. Overholt is no student of Sherlock Holmes. For as the great detective said

We are then left with 2 types of vehicles that use the parking lane on a regular bases....Buses and Large City Plows. Therefore: we are left with a vehicle that could do damage to the curb and move a post that


weighs more than 150 pounds....Any thoughts on this from you or Mr. Overholt???

Pictures 7 to 9: Show the temporary repairs that were made.






