Notice is hereby given that an ordinance that was introduced at the March 1, 2016 meeting of the Milwaukee Common Council, the essence of which is as follows:

A substitute ordinance relating to the change in zoning from General Planned Development to a Detailed Planned Development known as Block 8 - Arena Master Plan to allow for construction of the Milwaukee Bucks Training Facility on land located on the south side of West McKinley Avenue, west of North 6th Street, in the 6th Aldermanic District.

(2) The zoning map is amended to change the zoning for the properties located at: 1227 North 6th Street, Tax Key No. 362-0463-100; 1247 North 6th Street, Tax Key No. 362-0461-000; and 740 West Winnebago Street, Tax Key No. 362-0462-100, from General Planned Development (GPD) to Detailed Planned Development (DPD).

(J) The requirements set forth in said detailed plan attached to this aid detailed plan attached to this common Council File as Exhibit A, confirmed in greyllations for the area contained in such planned development district described provided further, that the effect of the approval of such detailed plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in such detailed plan.
