

Substitute ordinance relating to a change in zaning from Local Business to General Planned Development on land located on the South Side of West Lincoln Avenue and East of Sauth 5th Place, for affordable hausing with supportive services, in the 14th Aldermanic District.

(2) The zaning map is amended to change the zoning for the area bounded and described as follows:

Lots 4 and 5 in Block 3 in T. Kuczynsky's Subdivisian No. 2 being a subdivision of a part of Block 3 in Dr. E. Chase's Subdivision of part of the Northeast 1/4 of Section 8, Township 6 North, Range 22 East in the City of Milwaukee, County of Milwaukee and State of Wisconsin.
