Dear Licensing Committee,

This letter is my official complaint, and request that you consider revoking the extended hours license granted for the Marathon gas station at 35th and Garfield.

My home is across from this gas station. In August, I was awoken by gun shots near 2am, heard glass shatter, a car speed off, and subsequently found a young man, Lavelle Felton, was fatally shot. I heard a neighbor yell and ran outside to see this young man sitting in his car, shot in the head. I previously spoke at a Board of Zoning Appeals hearing and attempted to get the hours limited at that time, to no avail.

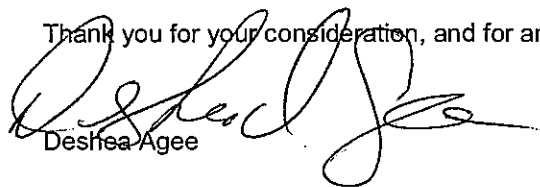
That early morning a person who had just left the gas station and returned stated at least four shots were fired when the lights were turned out. He had just spoken to Mr. Felton and Mr. Felton's relative who was in the car with him.

On October 7, I awoke to find another murder had taken place at this same gas station. I went outside at 5am and spoke with Gary Whitley, another property owner, who informed me of what happened. He stated between 1am - 2am a young person was killed at the gas station. This was Querronaceosam "Querro" Evans.

A number of incidents have taken place at this Marathon gas station throughout this summer, and over past five years including robberies, assaults, fights, drug selling, shootings, and most recently murders. I am hoping you will consider removing the extended hours of operation for this location. I understand an extended hours license to be a privilege, and should be earned. To me and others who have expressed concern with this gas station, more harm is being done to the neighborhood than good with the hours of operation allowed at this location. My attempt is not to penalize the owner of the gas station by reducing their income, but to make this neighborhood a better place for residents to live, and a better place for businesses to do business. Attached is a list of over 200 signatures requesting an immediate change in their hours of operation for your review.

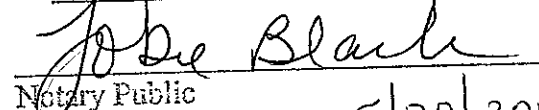
I am a parent, and a property owner who moved into this Metcalfe Park neighborhood to help make it better. I understand we have a long way to go, but steps must be taken to change this neighborhood. Please help me with changing the hours at this gas station so that the residents living here can rest peacefully at night, and no more families and friends of the victims are affected with grief by those who see this gas station as a place to get away with murder.

Thank you for your consideration, and for any help you can provide.

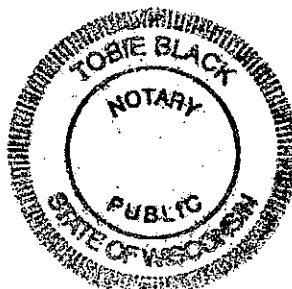
