Thanks to everyone for coming to the meeting on Tuesday or otherwise providing comment. Here's a summary of what we discussed:

- Platform: ICLEI Clear Path
- Scope: Priority 1 is community emissions for the geographic boundary of the City of Milwaukee, including Milwaukee County operations therein. We will get pricing from the consultant for doing all of Milwaukee County's geographic boundary as Priority 2 if the budget allows; We will be looking at Scope 1 and Scope 2 emissions, not Scope 3. We will get the price for adding solid waste to the measurement as well, and get more information on how trees factor in.
- Consultant selection: We will move forward with discussions with AECOM, working off an existing City contract. The consultant we will potentially be working with is named <u>Joshua Lathan</u>. We will try to document the methodology so that we can have local people update the inventory as needed

I spoke with the AECOM team after the meeting. Joshua is not available to start work until the middle of January; however, we will start getting pricing. Josh confirmed that it will be difficult to complete a GHG unless we get the right data from our utility.

Please let me know if I missed anything. I appreciate your thoughtful involvement on this.
