You are hereby notified that the Milwaukee Common Council will hold a hearing on December 1, 2009, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider the renewal of your public passenger vehicle license application.

Attached you will find a copy of the Report of the Public Safety Committee which includes its Findings of Fact, Conclusions of Law and Recommendation, recommending renewal of your license with a ninety (90) day suspension based upon the police report and driving record. The recommendation is the result of a public hearing before the Committee held on November 19, 2009.
