THE CHAIR

A substitute ordinance relating to parking controls.

This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-2 of the Code relating to No Stopping is amended by adding the following:

On the south side of West Canal Street from West Potawatomi Circle (old South 20th Street) to a point 116 feet east

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

"On the north side of West Pittsburgh Avenue from the east curb line of South 3rd Street extended, to the first north-south alley east thereof, at any time"

Part 3. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the north side of West Blue Mound Road from North 90th Street to a point 50 feet east

Part 4. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by adding the following:

On the north side of West Cleveland Avenue from South 30th Street east to the first north/south alley on school days from 7:00 AM to 5:00 PM

Part 5. Section 101-24-1 of the Code relating to Tow-away Zones is amended by adding the following:

On the south side of West Canal Street from West Potawatomi Circle (old South 20th Street) to a point 116 feet east
