E. Linnwood Ave. (Various Locations) - N. Newhall St. to N. Maryland Ave. (SM495030234) File

Number 030875: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$597,000)

7th Aldermanic District

N. 42nd St. - W. Burleigh St. to W. Fond du Lac Ave. (SM495040158) File Number 041350: Relay sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$510,000)

8th Aldermanic District

W. St. Paul Ave. - N. 17th St. to N. 20th St. (SM49505011) File Number 050225: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$160,000)

9th Aldermanic District

N. Servite Dr. and W. Brown Deer Rd. (RE52311064) File Number 040775: Asphalt surface, remove and replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and tree removal where necessary. (Nonassessable Developer Fund -- \$133,000)
