THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$9,127,000 for a total estimated cost of these projects being \$10,788,589.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$9,127,000. The total estimated cost of these projects is \$10,788,589.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

## 2nd Aldermanic District

W. Thurston Ave. - N. 91st St. to N. 92nd St. (ST211120183) File Number 111280: Relocate concrete walk. Doing all necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$30,000). The total estimated cost for this project including the requested amount is \$36,000. This project is anticipated to be completed during the 2012 construction season.

## 3rd and 6th Aldermanic Districts

Pleasant Street Vertical Lift Bridge over the Milwaukee River (BR100120104) File Number 110924: Moveable bridge rehabilitation including structural, mechanical, and hydraulic components (City Share Non-assessable Structure Fund -- \$7,150,000). (BR100120105) Moveable Bridge electrical work and material purchases. (City Share Non-assessable Structure Fund -- \$350,000). The total estimated cost for this project including the requested amount is \$8,200,000. This project is anticipated to be completed during the 2012-2013 construction season.

## 4th Aldermanic District

N. Milwaukee St. at E. Menomonee St./N. Young St. (ST211120189) File Number 111700: Intersection modification. (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$20,000. This project is anticipated to be completed during the 2012 construction season.

## 5th Aldermanic District

W. Hadley St. - N. 80th St. to 120 feet m/l west of N. 80th St. (SM495120044) File Number 111700: Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$13,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2012 construction season.

N. 80th St. - W. Lorraine Pl. to W. Hadley St. (SM495120043) File Number 111700: Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$33,000). The total estimated cost for this project including the requested amount is \$45,000. This project is anticipated to be completed during the 2012 construction season.

## 6th Aldermanic District

N. 22nd St. - W. Hopkins St. to W. Keefe Ave. (SM495120021) File Number 111474: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$414,000). The total estimated cost for this project including the requested amount is \$429,000. This project is anticipated to be completed during the 2012 construction season.

## 7th Aldermanic District

W. Concordia Ave. - N. 38th St. to 230 feet m/l west of N. 38th St. (SM495110096) File Number 111024: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$117,000). The total estimated cost for this project including the requested amount is \$129,000. This project is anticipated to be completed during the 2012 construction season.

N. 56th St. - W. Keefe Ave. to W. Melvina St. (SM495120023) File Number 111474: Sanitary and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$260,000). The total estimated cost for this project including the requested amount is \$275,000. This project is anticipated to be completed during the 2012 construction season.

13th Aldermanic District

Howard Avenue Water Purification Plant (WT450115200): Howard Soft Start pump contract (C641110111). (Nonassessable Water Fund (WT45010500A) -- \$500,000, Additional Funds). The total estimated cost for this project including the requested amount is \$1,073,589. This project is anticipated to be completed during the 2012 construction season.

14th Aldermanic District

S. 8th St. - W. Oklahoma Ave. to W. Morgan Ave. (SM495110106) File Number 111701: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$250,000, Additional Funds). The total estimated cost for this project including the requested amount is \$556,000. This project is anticipated to be completed during the 2012 construction season.
