An ordinance amending the Official Map of the City of Milwaukee.

113-32.0109

The adoption of this ordinance will update the Official Map of the City of Milwaukee.

Whereas, The Mayor and Common Council of the City of Milwaukee do ordain as follows:

There is hereby added to the City of Milwaukee Code a new section to read as follows:

Section 113-32.0109 the Official Map, as mentioned and provided for in Section 113-32, is hereby amended so as to include the following additions as shown in the report on file in the City Clerk's office.

Alley in the block bounded by West Fairmount Avenue, vacated North 36th Street, North 37th Street and the railroad right-of-way. The vacation of the remainder of the north-south 30-foot wide alley.
