This resolution approves a lease agreement between the City of Milwaukee and Cricket Communications for placement of personal communications antennas at 4001 S. 6th Street. Whereas, The Common Council adopted Resolution File Number 960170 on June 25, 1996, establishing a policy for the leasing of City facilities for the provision of wireless telecommunications services; and

Whereas, The Common Council further adopted Resolution File Number 991575 on February 18, 2000, amending said policy; and

Whereas, These resolutions designated the Department of Administration as the City's sole negotiating agent for marketing City-owned sites to communication services vendors; and

Whereas, The Department of Administration has been working with the Police Department, the Department of Public Works and the City Attorney's Office to negotiate a lease agreement with Cricket Communications for placement of personal communications services (PCS) antennas at 4001 S. 6th Street; and

Whereas, The lease agreement offers a fair market value to the City, protects other City interests,
