Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$4,861,000 for a total estimated cost of these projects being \$5,101,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$4,861,000. The total estimated cost of these projects is \$5,101,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

2nd and 9th Aldermanic Districts

W. Custer Ave. - N. 58th St. to N. 60th St. (SM495060049) File Number 060574: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$193,000). The total estimated cost for this project including the requested amount is \$208,000. This project is anticipated to be completed

during the 2007 construction season.

3rd Aldermanic District

N. Bartlett Ave. (Various Locations) - E. Thomas Ave. to E. Providence Ave. (SM495070030) File Number 061380: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$866,000). The total estimated cost for this project including the requested amount is \$878,000. This project is anticipated to be completed during the 2007 construction season.

E. Bellevue Pl. - N. Newhall St. to N. Bartlett Ave. (SM495060083) File Number 061095: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$77,000). The total estimated cost for this project including the requested amount is \$87,000. This project is anticipated to be completed during the 2007 construction season.

N. Milwaukee St. - The Milwaukee River to N. Water St. (TD04884032) File Number 061021: Installing new sanitary sewers. (T.I.D. Fund -- \$104,000). The total estimated cost for this project including the requested amount is \$104,000. This project is anticipated to be completed during the 2007 construction season.

N. Stanley Pl. - E. Walworth St. to E. Meinecke Ave. (SM495070021) File Number 061380: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$79,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2007 construction season.

E. Walworth St. - N. Humboldt Ave. to N. Stanley Pl. (SM495050070) File Number 050806: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$125,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2007 construction season.

N. 1st St. - E. Clarke St. to E. Center St. (SM495060069) File Number 061095: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$173,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2007 construction season.

N. 31st St. - W. Concordia Ave. to W. Burleigh St. (SM495070019) File Number 061380: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$947,000). The total estimated cost for this project including the requested amount is \$980,000. This project is anticipated to be completed during the 2007 construction season.

N. 46th St. - W. Hadley St. to W. Locust St. (SM495070029) File Number 061380: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$133,000). The total estimated cost for this project including the requested amount is \$147,000. This project is anticipated to be completed during the 2007 construction season.

The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2007 construction season.

W. Forest Home Ave. - S. 19th St. to S. 20th St. (SM495060085) File Number 061095: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$87,000). The total estimated cost for this project including the requested amount is \$97,000. This project is anticipated to be completed during the 2007 construction season.

W. Thurston Ave. - N. 60th St to N. 62nd St. (SM495070069) File Number 070367: Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$87,000). The total estimated cost for this project is \$87,000. This project is anticipated to be completed during the 2007 construction season.

N. 62nd St. - A point 225 feet m/l north of W. Bobolink Ave. to W. Thurston Ave. (SM495070070) File Number 070367: Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$143,000) The total estimated cost for this project is \$143,000. This project is anticipated to be completed during the 2007 construction season.

S. Amy Pl. - W. Burnham St. to a point 225 feet m/l south of W. Burnham St. (SM495070013) File Number 061229: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$43,000). The total estimated cost for this project including the requested amount is \$53,000. This project is anticipated to be completed during the 2007 construction season.

S. 13th St. - W. Hayes Ave. to W. Harrison Ave. (SM495070028) File Number 061380: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$354,000). The total estimated cost for this project including the requested amount is \$367,000. This project is anticipated to be completed during the 2007 construction season.

S. 15th Pl. - W. Lincoln Ave. to W. Cleveland Ave. (SM495060032) File Number 070367: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$705,000 The total estimated cost for this project is \$705,000. This project is anticipated to be completed during the 2007 construction season.

S. 15th Pl. - W. Mitchell St. to W. Burnham St. (SM495060015) File Number 070187: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$136,000) The total estimated cost for this project including the requested amount is \$156,000. This project is anticipated to be completed during the 2007 construction season.

S. Taylor Ave. - E. Euclid Ave. to E. Oklahoma Ave. (SM495060088) File Number 061095: Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$60,000). The total estimated cost

for this project including the requested amount is \$68,000. This project is anticipated to be completed during the 2007 construction season.

15th Aldermanic District

N. 32nd St. - W. Meinecke Ave. to W. Wright St. (SM495060044) File Number 060243: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$176,000). The total estimated cost for this project including the requested amount is \$188,000. This project is anticipated to be completed during the 2007 construction season.

N. 37th St. - W. Brown St. to W. North Ave. (SM495060079) File Number 061095: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$137,000) The total estimated cost for this project including the requested amount is \$147,000. This project is anticipated to be completed during the 2007 construction season.

Alley between W. Barbee St., W. Walnut St., N. 20th St., and N. 21st St. (East Half of East-West Leg - New) (TD02880000) File Number 070118: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (T.I.D. 28 Funds -- \$46,000). The total estimated cost for this project including the requested amount is \$46,000. This project is anticipated to be completed during the 2007 construction season.

E. Sivyer Ave. - A point 384 feet m/l west of S. Kigan Ave. to S. Packard Ave. (WT410070007) File Number 070367: Relay water main and hydrant alteration. (Nonassessable Water Fund -- \$85,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2007 construction season.
