Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$3,826,817 for a total estimated cost of these projects being \$4,181,837.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$3,826,817. The total estimated cost of these projects is \$4,181,837.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Hampton Av. - Bridge over Lincoln Creek (N. 31st St. to N. 32nd St.) (BR320062101/ST320062101)(2545-12-70) File Number 060882: Replace bridge, asphalt pavement resurfacing of bridge approaches, replace curb and gutter, sidewalk as necessary and grading. Grantor Non-Reimbursable Paving Fund--\$ 88,071 Grantor Reimbursable Paving Fund -- \$12,900 City Share Non-assessable Paving Fund--\$ 26,535

Grantor Non-Reimbursable Structure Fund--\$ 1,007,865 Grantor Structure Reimbursable Structure Fund--\$153,300 City Share Non-Assessable Structure Fund--\$ 305,146

- N. Marshall St. E. Juneau Ave. to E. Ogden Ave. (SM495070064) File Number 070081: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$198,000). The total estimated cost for this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2010 construction season.
- N. Maryland Ave. E. Hartford Ave. to E. Newport Ave. (SM495080034) File Number 080237: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$149,000). N. 46th St. - W. Center St. to W. Hadley St. (SM495070109) File Number 071055: Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$106,000). The total estimated cost for this project including the requested amount is \$116,000. This project is anticipated to be completed during the 2010 construction season.

N. 68th St. - W. Mt. Vernon Ave. to a point north of W. Mt. Vernon Ave. (Sponsored by the City of Wauwatosa) (ST211090150) File Number 090762: Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$12,000). The total estimated cost for this project is \$12,000. This project is anticipated to be completed during the 2009 construction season.

Movable Bridges Remote Control Upgrades (BR100090109): (City Share Nonassessable Structure Fund -- \$75,000). The total estimated cost for this project is \$75,000. This project is anticipated to be completed during the 2009-2010 construction season.
