Assure that measures are taken to provide an environment in which individuals can be healthy.</li> <li>CREATING AUTHORITY: Section 59-3-3, of the Milwaukee Code of Ordinances MEMBERSHIP Members shall be appointed by the Mayor and serve upon confirmation by the Common Council. Members shall reflect the diversity of the City based on current U.S. Census data. Among the members who are not elected officials, at least one shall be a registered nurse and at least one shall be a physician, as defined in s. 448.01(5), Wis. Stat. Five persons with backgrounds in science and public health including formal training and appropriate education credentials in these areas. These board members shall be current members in good standing of the professional associations</li> </ul>
