THE CHAIR

Resolution relative to application, acceptance, and funding of a Speed Enforcement 2012-13 grant.

This resolution authorizes the Milwaukee Police Department to apply for, accept, and fund a Speed Enforcement grant from the Wisconsin Department of Transportation, Bureau of Transportation Safety in the amount of \$60,000. The purpose of this grant is to detect and apprehend motor vehicle operators in areas with the largest number of crashes due to excess alcohol and speed.

Whereas, The City of Milwaukee appears to be eligible for a Speed Enforcement grant from the Wisconsin Department of Transportation, Bureau of Transportation Safety, and

Whereas, The operation of this grant from 10/01/12 to 09/30/13 would cost \$60,000 of which 100% would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Department of Transportation is authorized and the Police Department shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee
