THE CHAIR

Resolution relative to application, acceptance, and funding of a Click It or Ticket Enforcement 2012-13 grant.

This resolution authorizes the Milwaukee Police Department to apply for, accept, and fund a Click It or Ticket Enforcement grant from the Wisconsin Department of Transportation, Bureau of Transportation Safety in the amount of \$50,000. The purpose of this grant is to encourage seat-belt enforcement in areas with low seatbelt usage.

Whereas, The City of Milwaukee appears to be eligible for a Click It or Ticket Enforcement grant from the Wisconsin Department of Transportation, Bureau of Transportation Safety, and

Whereas, The operation of this grant from 10/1/12 to 09/30/13 would cost \$50,000 of which (100%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin

Department of Transportation is authorized and the Police Department shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2012 Special Revenue-Grant and Aid Projects, the following amount for the program titled: Click It or Ticket Enforcement 2012-13 Project Grant:

1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date.
