Resolution authorizing the application, acceptance and funding of the 2012 Environmental Workforce Development and Job Training Grant from the Environmental Protection Agency through the Community Development Grants Administration.

This resolution allows the City of Milwaukee to apply and accept funding from the Environmental Protection Agency - FY 2012 Environmental Workforce Development and Job Training Grant in the amount of \$200,000.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Environmental Protection Agency - FY 2012 Environmental Workforce Development and Job Training Grant in the amount of \$200,000; and

Whereas, The Job Training Program will train 80 persons in environmental occupations; and

Whereas, The operation of this grant from 10//01/2012 through 09/30/2015 would cost \$234,000 of which \$34,000 would be provided by the local share and \$200,000 would be provided as the grantor share; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Community Development Grants Administration shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it
