AIDS Fund through Diverse and Resilient in the amount of \$50,000 provided by the grantor. The purpose of the grant is to address unfavorable social conditions for young gay and bisexual men, especially young African American gay and bisexual men that results in limited HIV prevention information and high risk situations and behavior that contribute to HIV transmission.
