This resolution establishes the 2009 Solid Waste Charge in accordance with s.79-6 of the Milwaukee Code:

- 1. \$42.25 per quarter per residential unit for one, 2, 3, and 4 family dwelling units.
- 2. \$42.25 per quarter per cubic yard for properties other than those specified under item #1.

Whereas, Section 79-6 of the Milwaukee Code of Ordinances established a Solid Waste Charge, as authorized pursuant to Sections 66.0405 and 66.0627, Wis. Stats.; and

Whereas, Section 79-6 of the Code requires adoption of a resolution on an annual basis that establishes the Solid Waste Charge; now, therefore, be it

Resolved, By The Common Council of the City of Milwaukee, that the 2009 Solid Waste Charge is established in according with s.79-6 of the Code, and imposed on a quarterly basis:

- 1. \$42.25 per quarter per residential unit for one, 2, 3, and 4 family dwelling units.
- 2. \$42.25 per quarter per cubic yard for properties other than those specified under item #1.
