Dear Milwaukee Alderman,

I am very concerned about the proposed mask legislation before the Common Council. I know your intentions are good, but the science behind the usefulness of masks (particularly homemade masks that are ill-fitting and reused lots of times, typically without proper cleaning) is dubious at best. These masks cannot filter the size particles that are emitted by Covid sufferers - unless they are made so thick that people can't breathe through them. And there are possible negative health effects from the (common) misuse of these masks.

Aside from the medical concerns surrounding masks, what we need right now is side not another issue to divide us and pit neighbor against neighbor, particularly when people are feeling isolated and alone and are silently (and not so silently) judging everyone they come in contact with. I have a 3-year-old. It's not possible to keep a mask on a young child for any length of time - and the amount of face touching involved by both child and parent in this battle will undoubtedly cause more health issues than any possible benefits. And, personally, being 31 weeks pregnant, it is basically impossible for me to wear a mask for more than a minute or two without feeling nauseous and like I can't breathe. So, a mask mandate would basically make me a prisoner in my own home, as I wouldn't even be able to take a walk with my son legally.

Hello,

First off, I would like to begin by thanking each of you for taking the brief moment to read this message.

My name is Alyssa Richter, and while I am not a city of Milwaukee resident, I spend lots of time working and money in the city throughout the year.

I feel that it is absolutely unnecessary to have a mask mandate in the city. There are several reasons why, which I will begin to discuss.

First, while we may have "spikes", the hospitals are not overcrowded as shown on [WHA.org](https://www.wa.gov/health/our-work/communicable-diseases/covid-19) dashboard. For many individuals, should they be infected, they will experience symptoms no worse than a cold or flu. The goal of the curve flattening was never to eradicate the virus, it was only allow hospitals to prepare and gain enough PPE. The goal posts have constantly been moving throughout this, and it has turned extremely political.

Second, looking at the New England Journal of Medicine and their study on universal masking, they clearly came to the conclusion "that wearing a mask outside of a health care facility offers, little, if any protection from infection." (<https://www.nejm.org/doi/full/10.1056/NEJMp2006372>)

I have hardly seen this covered by the news media, and in turn, why are local health departments not considering this in their mandates? They also state "the desire for widespread masking is a reflective reaction to anxiety over the pandemic."

Which leads me to my next point, mental health. Throughout all this over the last few months, we have been completely dismissive of people's mental health, which at many points in recent times, has been something discussed by many. We are only creating and ramping up additional fear and anxiety by mandating people to wear masks, which is something nobody needs anymore of right now. In considering this, what about people that have suffered trauma in their lives that prevent them from wearing a mask? Should they be forced to stay home or not be able to enjoy the small portion of summer in Milwaukee that we do have because of something that was out of their control? There is no one size fits all here, and you're risking a slippery slope should you enact a mandatory mask policy.

At what point in time has the government ever been able to force someone to purchase or wear a certain type of clothing or face covering? To my knowledge, there has never been such an occasion, even during the Spanish flu, except



in certain locations. I feel that this is complete overreach to force people to do something, when we live in the greatest country in the world, which was founded on the freedom to choose and do as we wish.

While there have been many suggestions from the CDC and WHO telling people to wear masks, why are they still being taken seriously? They based the spread of the virus on inaccurate models, as well have offered contradictory advice that tends to change by the day. The WHO has also spread false information regarding China's report of the virus, according to the following article.

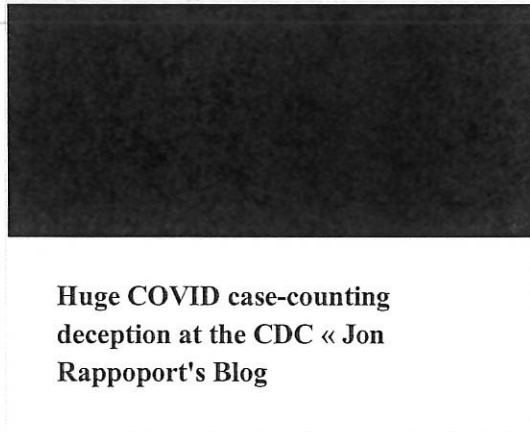

His allegedly unethical behavior creates false hope and could result in premature deployment of the vaccine.” The tribunal recommended investigation by a “fully independent outside investigative body.” Dr. Redfield confessed to D.O.D. interrogators and to the tribunal, that his analyses were faulty and deceptive. He agreed to publicly correct them. Afterward, he continued making his false claims at three subsequent international HIV conferences, and perjured himself in testimony before Congress, swearing that his vaccine cured HIV.

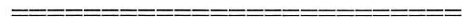

Mask-wearing can also increase the risk of infection and the spread of viral illness, hinder detoxification that occurs via exhalation, impair the immune system and cause many other ailments, both physical and emotional. Moreover, some masks have been found to contain known carcinogens, which put people at risk from inhaling toxic chemicals and having them come into contact with their skin.

Lawsuits are now being filed throughout the country to challenge mandatory masks. **Despite evidence of harm and questionable evidence of benefit**, fall 2020 school guidelines across the country are calling for mandatory masks. Public school

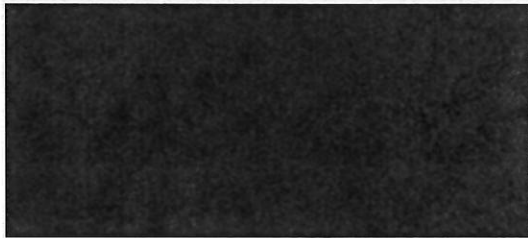
systems (e.g., San Diego, California) are concerned that mask requirements in the classroom will spark even more legal battles.
