Resolution congratulating Captain Patrick T. Pajot on his retirement from the Milwaukee Police Department

WHEREAS

CAPTAIN PATRICK T. PAJOT

retired with pride and satisfaction as a Police Captain with the Milwaukee Police Department on March 14, 2025 after over 25 years of dedicated service to the City of Milwaukee; and

WHEREAS, Captain Patrick Pajot began his career with the Milwaukee Police Department in 2000 and was assigned to District Two after graduating from the Police Academy, and there he was assigned to the Anti-Gang Unit, working closely with the community to reduce gang violence, and, in 2004 he was transferred to the Gang Crimes-Intelligence Division, where he continued to work on reducing gang violence; and

WHEREAS, Captain Patrick Pajot was promoted to Detective in 2008 and was briefly assigned to Violent Crimes, soon returning to the Homicide Unit, and in 2021, he was promoted to Captain of Police and assigned as the Criminal Investigation Bureau Night Watch Commander, with later assignments included as the commander of Violent Crimes Division with the Criminal Investigation Bureau in September 2021 and as the commander for District Two in December 2021; and

WHEREAS, Captain Patrick Pajot is a 2011 graduate of Leadership in Police Organizations program and a 2018 graduate of Northwestern University Supervision of Police Personnel, and was the commander of the Crisis Negotiations Unit, being an active member of the unit since 2010; and

WHEREAS, Captain Patrick Pajot richly and justly earned the enduring praise, respect and gratitude of his coworkers, friends, family and the community at large for his dedication and service to the Milwaukee Police Department and to the City of Milwaukee; and

WHEREAS, Captain Patrick Pajot gained and displayed expertise through his work and performed with confidence and skill during his employment, earning him the Milwaukee Police Department Officer of the Year Award in 2008; now, therefore, be it

RESOLVED, That the Common Council of the City of Milwaukee herewith congratulates Captain Patrick Pajot on his retirement from the Milwaukee Police Department, extends its appreciation on behalf of the community, and wishes for him a happy and healthy retirement; and, be it
