Dear Mr. Grady:


We have received your claim in the amount of \$500.00, relating to a Diamond earring that was allegedly inventoried after your arrest by the Milwaukee Police Department (MPD) on May 25, 2006 for various charges.

Our investigation reveals the MPD were dispatched to 4714 North 46th Street to investigate a threat complaint. They then proceeded to 3225 North 13th Street and took you into custody related to this matter. You were then transported and subsequently booked into the Criminal Justice Facility and booked by the Milwaukee County Sheriff Department. The MPD inventory does not reflect that any Diamond earring was inventoried. Our office also spoke with the arresting police officer and he did not recall you having an earring on your person. Since there is no evidence to support your belief that the MPD inventoried your Diamond earring, the City cannot accept liability in this matter, as such; we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
