He has had to find a new installer and hopes to have the cameras installed as soon as possible. He stated he has security on scene until 7:00pm.

8. On 11/23/2020 at 6:10pm officers investigated a Shot Spotter call at 4101 W. Fond du lac Av. On 11/24/2020 officers went to Citgo gas Station at 4137 W. Fond du lac Av to check for video. The officers interviewed the applicant who stated he could not show the officers video without a warrant.

10. On 12/30/2021 the applicant was cited in the City of Milwaukee at 4409 N. Evans St. for Assault and Battery.

11. On 05/23/2022 at 7:24am officers were dispatched to an Armed Robbery at Citgo, 4137 W. Fond du lac Av. The officers interviewed the clerk, who stated two subject came in the store. One subject produced a gun and demanded money. The subjects fled on foot through the alley. The officers were able to recover video from the interior cameras but the cameras on the alley were not operational.
12. On 06/13/2022 at 2:15am officers were dispatched to a Shot Spotter at 4137 W. Fond du lac Av. The officers spoke with an employee, who stated a customer exchanged words with two males outside. One of the subjects produced a gun and the first customer fled inside the store. The employee then heard several shots fired but is unaware of who fired them.
13. On 07/22/2022 at 10:11pm officers were dispatched to a Battery at 4137 W. Fond du lac Av. The investigation revealed a former employee came to the store with his girlfriend and together they caused damage to the store. The employees were cooperative and provided video of the incident.

14. On 11/14/22 at 2:04am Milwaukee Police were dispatched to 4137 W. Fond Du Lac Av., for a shooting complaint. Officers arrived on scene and observed a female victim with a gunshot wound to her leg. The victim stated that she is homeless and was resting inside her auto when she was awoken by gun shots. The victim stated that she then tried to leave her vehicle and was struck in her left ankle. The victim then crawled to the gas station entrance and was helped by security. Security assisted the victim into the store and called the police. Officers spoke with the gas station clerk, who stated he heard the gun shots but did not see where they came from. The store clerk was cooperative with the investigation and provided video. Further investigation revealed a second victim was admitted at Mt. Sinai hospital.
15. On 05/18/23 Milwaukee Police were dispatched to 4137 W. Fond Du Lac Av., for a Reckless Use of a Weapon complaint. Officers spoke with the victim, who stated that he and his co-worker were doing construction work outside, in the parking lot of the business. Both workers were struck by a paint ball gun by an unknown suspect. The victim stated that the suspect then left in a vehicle east from the location. Police reviewed video of the incident, obtaining suspect information and vehicle information, and filed reports regarding.
16. On 06/03/23 at 1:29 am Milwaukee Police were dispatched to 4137 W. Fond Du Lac Av., for an armed robbery complaint. Officers spoke with armed security who stated that four subjects entered the gas station store and one of the subjects removed his gun from his holster. Security chased after the subjects and the armed subject fired a gun shot at his direction. The suspects then all left in a silver vehicle from the location. Officers reviewed the video footage which captured the incident in it's entirety. Officers spoke with the clerks that were working, and the business was cooperative with the investigation.
17. On 06/09/23 at 2:35am, Milwaukee Police were dispatched to 4137 W. Fond Du Lac Av., for a shot spotter assignment. While officer were in route a separate police squad was in a chase with a suspect vehicle that fired gun shots. Officers spoke with the security guard who stated that he observed subjects arguing in a car and observed a subject with his arm out the car

firing a gun in the air. Officer's observed one spent casing on the floor of the gas station out of 8 reported. Officers reviewed the video footage and observed the suspect vehicle and suspect fired several gun shots in the air, from the vehicle. The other squad subsequently stopped the suspect vehicle and the front passenger was the same suspect observed in the video firing gun shots in the air at the gas station. The suspect was taken in custody regarding.

18. On 07/15/23 at 1:36am, Milwaukee Police were dispatched to 4137 W. Fond Du Lac Av., for a shot spotter assignment. Officers spoke with security who stated that he did not see or hear any shots fired, then realized that there was damage to the business window. The clerk employee stated that he did not see anything from behind the employee area glass window. Officers reviewed video and the incident was not captured on video surveillance. All business licenses were current.

19. On 07/29/23 Milwaukee Police were dispatched to 4137 W. Fond Du Lac Av., for a subject with gun complaint. Officers spoke with the caller who was outside the gas station. The caller stated that he observed two subjects go into the store and take some candy. The subjects came back and one of the subject had a hand gun tucked in his waist band. The subject then pulled out the gun and had it down by his side. The subjects then left the location. Officers then spoke with the clerk who stated that two subjects did steal candy and returned but never entered the store. The clerk stated that he did not see a gun and the subjects tried to scare the caller. The clerk was cooperative and did not want anything done regarding the merchandise.

20. On 09/13/23 at 12:37p.m., Milwaukee Police were dispatched to a Battery at 4137 W Fond du Lac. Officers were advised an unknown subject slapped the clerk for an unknown reason. They did not want to file a report and only requested extra police presence.

21. On 01/25/24 at 12:56a.m., Milwaukee Police were dispatched to a Trouble with Subject at 4137 W. Fond du Lac Ave. On arrival officers were directed to the subject who was causing a disturbance and requested they leave, which they complied.

Fond du Lac Ave. Officers recovered 11 spent casings in the parking lot as well as 6 other casings in the area. The clerk stated they heard the shots, however, did not call the police because they knew a customer did.

Vitim. Security camera footage was available for officers to review, and the security guard was arrested.

26. On 04/20/25, at 4:36 a.m., Officers were dispatched to a Battery complaint. A security guard called for police service after two actors engaged in a physical fight outside of the business. Both actors were not on scene upon officers' arrival.

On Sunday, December 1, 2024 at 1:48 AM, Squad 7330 (PO Jacob BLANCO and I) were dispatched to a Shooting Complaint at 4137 W Fond Du Lac Av, 53216. This premise is located in the City and County of Milwaukee, Wisconsin.

Upon arrival officers spoke to the armed Security Guard, Todd L SHIELDS (B/M 05-22-1965) who stated that he called the police after he observed the victim, Thomas J MARTIN (B/M 10-15-1980) stating that he was shot. MARTIN's vehicle (2006 Chevrolet Monte Carlo PLT#ALT8988) was parked at Pump 5 and had several trails of his blood on the parking lot and the driver's seat. SHIELDS stated that he did not hear any shots.

I spoke to the cashier, Manpreet SINGH (A/M 01-04-2001) who did not hear any shots and was fully cooperative with the investigation, allowing us to hold the store and review camera footage. Camera footage showed MARTIN hobbling out of his vehicle and flagging down SHIELDS and then standing
