Subject: Scene One Nightclub 5524-5526 Opposition Nuisance Bar

I am in opposition of Scene One Nightclub 5524-5526 W North Ave getting Public Entertainment Premises and Class B Tavern License. This is a residential neighborhood of 22 houses on every block every direction. Whenever they are open we have almost non stop noise and disorderly incidents which I shouldn't have to deal with after 10 pm from the patrons. To include fights of patrons on the street and outside the bar at all hours, sitting in the cars outside smoking marijuana to go back in club, urinating in the alley, sexual activity behind the bar, guns going off on the block on 56th street and the alley during hours of the bar and right after closing. Numerous times have had to call 911 for bullet casings on the 2300 block of 56th / 57th where they come out and put the numbers around casings. The past few months while scene one has been closed all that nuisance and safety issues have almost disappeared. Same as when they were closed from a previous ATF incident during covid it was peaceful. Whenever the bar opens back up the incidents increase to a ridiculous and unacceptable amount. This is not Brady Street or Water St which the alderwoman has compared our street too. That is absolutely ridiculous. Ventures Brew 9 PM, Paloma Taco and Tequila 10 PM and McBobs closes 10 PM all respectively close for the neighbors. Scene One claims 70 % of their revenue is from food and 30 % for liquor then why do they need to be open after 10 PM if that's actually true. The Owner of Paloma Taco & Tequila had come to a meeting of concerns about Scene one and said they also have 70 % Food and 30 % alcohol sales and see no need to be open after 10 pm that no good happens after 10 pm they lock their doors in respect of neighbors. Car alarms going off, patrons yelling walking to their cars at 1 or 2 in the morning. No other bar in uptown is open these hours with a public entertainment license with them having DJS where the base vibrates down the street and neighbors can hear it inside the house. I have properties on 56th, 57th & 58th street and I have tenants complaining for the noise and patron fighting that they are concerned for their safety when the bar is open. Scene one has changed who the license is under to circumvent the licensing for alcohol and Tyron D Whigham the owner of the building has always been heavily involved in this bars you will see him at the bar until close on weekends but due to him having a record uses other people to get the license. They have so many filed non payments with DOR and always serve tobacco hookah without a license, even ambulance has been called to the bar for someone passing out because they do not have proper ventilation for the hookahs they sell. They show utter disregard for licensing and do not adhere to what is discussed every year. After last years hearing they AGAIN had a another ATF incident where they went in with MPD 3rd district. I am asking the board to put an end to this year after year situation with Scene One which license issues for this bar previously called Narrow Tavern go back to 2011, The current owner Tyron Whigham and Howard Tice are both still on the title as they ongoing court for the building non payment issues. they should have the same hours as all the other bar establishments in uptown like Ventures & McBobs. I don't understand why they are permitted to take over our neighbors' peace and safety after 10 PM. Drinking in public, loitering after bar close, harassing those that live on the block, assault / fighting that occurs from patrons leaving drunk. Thank you for hearing me out.
