We would like to rebuild the front porch to repair the missing stairs and damage from where the concrete deck has pulled away from the porch. See below for proposed

Work to be performed at:

- Building permit by Orta Construction Inc.
- Temporary supporting of porch roof while porch rebuild occurs
- De-consturction of porch while saving front porch brick and lannon stone to be reused in rebuild.
- Removing existing foundation and concrete slab, digging down trenches to pour new concrete foundation and installing new foundation wall 4 feet down per code.
- Installing existing brick using lime mortar, using new similar brick to accomplish project. New brick will be installed on interior face of porch so it is not visible from street
- Pouring new 4" concrete slab on top of new compacted crush stone
- Rebuild two stairways.
- Replacing existing window sills at south elevation bay window.
- TUCK POINTING 100% of house and chimney 5/8" deep using lime mortar.
