PLEASE TAKE NOTICE, that pursuant to Sec. 893.80, Wis. Stats, We Energies, 231 W. Michigan St., Milwaukee Wisconsin by Mary Ritenour, Claims Analyst, hereby gives notice that on or about December 13, 2010 the claimant discovered damage and associated loss of electrical consumption at 812 E State Street, Milwaukee, Wisconsin, as a direct result of city conduit installation in 2010.

PLEASE TAKE FURTHER NOTICE, that at the aforementioned time and place, the claimant sustained damage to underground 3 phase secondary electric cable as a result of excavation by City of Milwaukee crew during underground conduit project which began in April 2010.

PLEASE TAKE FURTHER NOTICE, that all times material City of Milwaukee through its officials, employees, agents or representatives, including but not limited to Milwaukee Department of Public Works was careless and negligent by not observing accurately marked locate marks during excavation and striking We Energies electric cable.

PLEASE TAKE FURTHER NOTICE, that the damages suffered by We Energies were directly and proximately caused by the negligence and carelessness of City of Milwaukee in that its employee in the normal course of employment did strike and damage We Energies electric service; pulling cable up and over city conduit removing all slack in manhole, and causing service to fault.
