Resolution congratulating Christian M. Farney on achieving the rank of Eagle Scout.

WHEREAS,

CHRISTIAN M. FARNEY

was honored with an Eagle Scout Court of Honor at the Mitchell Park Pavilion by Boy Scout Troop 536 on March 18, 2023, for attaining the highest rank of Eagle, an exceptional accomplishment only achieved by six percent of all scouts; and

WHEREAS, *Christian M. Farney demonstrated skills important in everyday life while fulfilling the requirements for this distinguished honor, and earned merit badges recognizing his leadership, citizenship and community service; and*

WHEREAS, *For his Eagle Scout Project, Christian M. Farney recycled tires that would have otherwise been discarded in landfills, repurposing them instead into 22 animal beds for the Humane Animal Welfare Society in Waukesha (HAWS); and*

WHEREAS, *Christian M. Farney devoted nearly seven years to scouting, serving in several leadership roles including Assistant Patrol Leader, Patrol Leader, Assistant Senior Patrol Leader, and Senior Patrol Leader, while receiving numerous awards during this period including the Arrow of Light Award, the Century Award, and 43 merit badges, 23 more than necessary to qualify for the rank of Eagle; and*

WHEREAS, *Christian M. Farney, known by his community for his work ethic and the quality of his leadership, has and continues to live the 12 points of the Scout Law, The Scout Oath, and the Outdoor Code; and*

WHEREAS, *Christian M. Farney's commitment to his fellow scouts and his willingness to always complete the task that is required of him has placed him in the highest rank of the Boy Scouts of America; now, therefore, be it*

RESOLVED, *That the Common Council of the City of Milwaukee herewith congratulates Christian M. Farney for achieving the Eagle Scout award, commends him for his outstanding service in the community and wishes for him success in all of his future endeavors; and, be it*
