This office is in receipt of your claim in the amount of \$1,069.73, relating to damage sustained to your vehicle on July 10, 2001 when a tree limb allegedly fell on it at 4363 South 20th Street.

Our investigation reveals that this loss was not in any way related to negligence by the City of Milwaukee. Prior to this incident the tree was alive. The damaged branch was not decayed, nor was any decay visible from the exterior of the tree. As such, the City would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
