This report was written by PO David NOVAK assigned to License Investigation Unit days.

On Saturday October 26, 2019 I was assigned to work the Wisconsin WINS Youth Tobacco Initiative, which checks area vendors for age compliance tobacco purchases. Assisting in this assignment was Tamesha A ROBERSON (b/f, 04/21/2002). ROBERSON is 17 years old and is not of legal age to purchase tobacco.

At approximately 9:42am ROBERSON entered the One Stop Pantry at 9622 W. Fond du lac Av. She was able to purchase a Black and Mild cigar from the cashier for \$1.00. ROBERSON stated the clerk did ask for an ID but made the sale anyway. I entered the store and the described cashier was identified as Hardip SINGH (w/m, 04/03/1990). SINGH stated he checked her ID and it said she was born in 2002. I advised him that the year was correct and that made her 17 years old and too young to purchase tobacco. I spoke with the agent, Pritpal S GREWAL, by phone and advised him he would be receiving a citation for Sale of Cigarette to Minor/Underage. GREWAL asked if I could issue the citation to SINGH because every morning he texts all the clerks at his 18 stores and advises them to not sell tobacco products to anyone born after the current date. I looked at the messages SINGH received and he did receive a message that morning at 8:32am from GREWAL advising him to not sell to anyone born after 10/26/2001. GREWAL stated that all the clerks know that if they sell to a minor the owner gets the ticket and they don't so they have no fear of being punished. He also stated they do not fear being fired because another gas station will immediately hire them.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
