Dear Ms. Horton:


We have received your claim in the amount of \$452.00, relating to damage allegedly sustained to your fence and gate at 3669 South 15<sup>th</sup> Street when a City skid loader struck it on November 6, 2006 while picking up debris.

Our investigation reveals the Fleet Accident Report completed as a result of this incident noted there was no evidence that the skid loader did any damage to the gate and fence. The City driver assigned to this job also stated that he did not hit the gate and the area was in the same condition as he found it. Since there is no evidence to support your belief that the skid loader caused your loss, and we must take credence in the testimony of the City employee, as such, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
