Install traffic calming speed hump(s).

**W. Metcalf Pl.-N. 97th St. to N. 100th St. (ST211180120).**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8' width of tree border area), and grading.

Concrete pavement reconstruction, replace all curb and gutter, sidewalk and driveway approaches, narrow the roadway from 40 feet to 36 feet, sodding (12' width of tree border area), and grading.

Install traffic calming speed hump(s).
