This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/18/23 at 1:06a.m., Milwaukee Police were dispatched to Assist an Officer at 4040 S. 27th St. Investigation revealed an off-duty Officer was at the premise celebrating a birthday, when security staff and the family of the officer got into a physical altercation. Officers were able to view video surveillance which depicts a security officer striking a patron in the head with their firearm and a friend of a security guard striking another patron, causing injuries. The manager was cooperative with the investigation.
- 2. On 03/23/23 Milwaukee Police held a meeting regarding Item #1. In addition to members from the Milwaukee Police Department, in attendance were management from the establishment as well as the Community Prosecutor and a member from the BID. Security protocols were discussed and the meeting was well received by all.
- 3. On 06/14/23 at 4:45p.m., Milwaukee Police were dispatched to a Trouble with Subject at 4040 S. 27th St. Investigation revealed a patron entered the bar and ordered food, however, became argumentative with other patrons. Staff requested the patron leave, however, they refused. The officer made contact with the patron who then left the premise. The manager was cooperative with the investigation.

4. On 07/25/23 at 9:31p.m., Milwaukee Police were dispatched to a Threat at 4040 S. 27th St. Investigation revealed a patron, who was highly intoxicated, was refused service at the bar due to the level of intoxication. The patron became argumentative with both staff and friends they arrived with. The patron then threatened to get a gun and use it on everyone. Due to statements made by the patron in the past to their friends regarding owning a gun and a backpack in the rear of the car they arrived in, once the patron entered the back seat of the car, employees and the patrons feared the patron did have a gun and police were called. The employees were cooperative with police and later provided officers with video surveillance of the incident.

This report was submitted by Officer Frederick TERRIQUEZ assigned to District 6, Early shift and equipped with a body worn camera.

On Saturday, March 18th, 2023, at 1:06pm, Officer Harry ALMAS and I, squad 6240 were dispatched to an Assist Officer assignment at the JB's on 41 bar and bowling alley, 4040 S. 27th St. in the city of Milwaukee. The caller stated there was a fight inside the bowling alley and the security guards were beating patrons up and pointing their guns at them.

Also responding to the scene were the following squads: Squad 6340 (Primary investigators), Squad 6390, Squad 2350, Squad 6313 (Supervisor) and various City of Greenfield Police Squads.

Upon arrival officers spoke with the complainants, one being a Milwaukee Police Officer, who stated he and some family and friends were celebrating his birthday at the bowling alley. At approximately 1:00am, (Closing time) the two security guards who were working in the business, were being rude in an attempt to rush them out the door.

While exiting the bowling alley the security guards and the complainant family got into a physical altercation leading to various patrons getting hurt.

While reviewing the surveillance footage, it was revealed that the following occurred:

- -One of the security guards, struck a patron in the head with his firearm and pointed it at others.
- -The other security guard struck another patron causing injuries
- -The girlfriend of one of the security guards struck another patron causing injuries During the course of this investigation the following subjects were arrested:
- Tracy B. SMITH, b/m, 04-06-70 of Adin Protection Agency (RES)
- Tracy D. SMITH, b/m, 08-16-90 of Adin Protection Agency (Battery)
- Chianti Maria MAHAN, b/f, 08/22/78 (Tracy D. SMITH's girlfriend) (Battery)

I spoke to the General Manager at J.B's on 41, Chris GOELLER. Chris, who is a new

On Thursday, March 23rd, 2023, we conducted a meeting with the management of JB's On 41. The meeting was held at District 6. In attendance was Christopher GOELLER, and Kyle KORTH, management for JB's. The following members of District 6 were in attendance, Captain Eric PFEIFFER, Sgt. Gary CHERONE, Police Officer Fabian GARCIA, Community Prosecutor Francesco MINEO, and myself. Tara CAVAZOS, from the HWY 41 BID was in attendance as well.

The meeting was to discuss security protocols for JB's after an incident that occurred on March 18th, 2023 (23-LP-0666). The management advised us that they have been in communication with corporate office regarding the incident and the security company that they hired. We were advised by management that the corporate makes all decision regarding the hiring of security. A further discussion was had regarding if security needs to be armed security in this particular environment.

Overall, the meeting was well received by both parties. Moving forward a meeting with the corporate office will be held on April 13th, 2023, hosted by Hwy 41 Bid. The District 6 Community Partnership Unit will conduct a CPTED/Security survey at the location with GM GOELLER at a later date.

On Wednesday, June 14th, 2023, at 4:45pm, Officer Thomas KRESA and I, Squad 6240 went to J&B's on 41 bowling alley, 4040 S 27th St. for a trouble with subject complaint. The caller stated a female at the location is threating staff and appears to be on some type of drug.

Upon arrival, officers observed the business to be operating at normal capacity.

I spoke to Mitchell Thomas HENDRIX-KING, w/m, 07-11-96, (719-551-8127) the manager of the bowling alley. Mitchell stated a female who came in at 3:00pm, was sitting at the bar. She originally ordered food but then after eating began to threaten staff. Mitchell stated she appeared to be on drugs since she was acting peculiar by talking to herself. Mitchell stated she started to get loud with other patrons and that was when he called police.

Mitchell pointed out the female to police. He stated he just wanted her off the premises and not to return.

Officer KRESA and I walked over and spoke to the female subject. She was described as a w/f, 30 years of age, 5 foot, 4inches tall on a thin build. She carried a handbag and textbooks. She asked to speak with her lawyer. She appeared aloof to our questions but left the bowling alley when asked to.

Mitchell stated he had several other staff on scene but no security employees working at this time. Surveillance video was operable and licenses were visible and posted at the bar. A free-standing metal detector was set aside the west wall, across from the bowling counter for future use on the weekends. No violations were observed at this time.

This report is typed by PO Frank HEEG, District 6 and Early Shift, assigned to Squad# 6251 with PO Raymon PORCHIA.

On Tuesday, July 26, 2023, at 9:31 PM, PO PORCHIA and I were dispatched to 4040 S. 27thSt., JB's on 41, for a threat call for service. Upon arrival I observed 3 individuals standing outside the front entrance, flagging us down in regard to their friend who was making threats to staff and them, stating he was going to use a gun against them and that he had locked himself in one of his friends' cars where the windows were tinted. At this point we called for additional resources due to the gun factor. At this point we had an additional 4 squads respond (6220, 6240, 6241, 6290) along with a Sergeant (6211).

I spoke to the initial caller, the manager, Steve R LEBRE (w/m, 03/02/1965), who called from the business phone (414-281-8200) who stated that he was refusing to serve alcohol to the subject, who was later identified as Victor H GONZALEZ (w/m, 03/11/99), due to the level of his intoxication. LEBRE stated GONZALEZ began to become belligerent and confrontational with him and the individuals who he arrived with. LEBRE stated that his friends, identified as Cheng Y MOUA (a/m, 08/24/98), Hector E ACEVEDO (w/m, 11/21/94) and Mark D WELCHMAN (w/m, 11/21/96), were attempting to calm him down and that is when he started to make threats that he had a gun and was going to use it on them. It was determined that the three individuals who I spoke to on arrival were MOUA, ACEVEDO, and WELCHMAN. MOUA stated that when the staff refused to serve GONZALEZ he started to get angry and started to call the manager names. He stated that when him and his two friends attempted to calm him down, he started to threaten them, stating he was going to go get his gun and kill them and their families. MOUA stated that GONZALEZ was initially refusing to leave, but exited the location and entered the back seat of his (MOUA) car. He stated that although he did not see him with a gun at this time, he always bragged about having a gun on him in the past and he was absolutely sure that he owned a gun. MOUA stated to us that he was in the back seat of his car, which was tinted, and did have a backpack with him which could easily conceal a firearm. It was at this point we called for additional squads. ACEVEDO and WELCHMAN did not make actual statements to me, they just confirmed what MOUA stated.

The business was completely cooperative with the investigation, although they do not have a security staff, they do have surveillance video inside and outside of the business, but they would have to get permission from the corporate office in order to get the video. LEBRE stated that he was the lowest level of manager and did not know how to work the system, but in the meantime, he would work on getting

the right manager to location so that he could pull up the video for us. So, at this time I was unable to review video, but it was recovered by squad# 6390 at 5:37 AM.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the threat call for service I did not observe any violations in the licensed premise.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
