- 1. Fund 15 and 17 (0150, 0170) are included, but are for Grant & Aid Projects and CDBG. This makes up approximately \$2.8 million of the \$5.7 million over 4 years.
- 2. Injuries and Damages (Account 636506 included) comprises \$270,000 of the total.
- 3. The numbers do not include refunds for overpayments or deposits 4. THE NUMBERS REPRESENT PAYMENTS MADE TO ENTITIES WHOSE ADDRESS IS IN THE 53206 AREA CODE ONLY.
- 5. The number DO NOT include funds that could have been spent in the 53206 area code, but were paid to an entity whose address was not in that area code.
