The Department of City Development reports that the tax foreclosed property located at 3160 North 9th Street, Tax Key #283-1228-100, is not suitable for use by a public agency or community-based organization.

The residential property was occupied at the time of City acquisition but is now vacant. City staff were unable to inspect the premises. Administrative costs incurred by the Department total \$500.84.

On January 24, 2024, there was a fire at the premises that resulted in a fatality and the displacement of the occupants of the home. Photos of the property condition are attached below. According to the Milwaukee Fire Department, the property had been converted from a two-unit structure to a one-unit structure where different households shared a kitchen and bath facilities. There is no permitting on file for this conversion of use.
