**2nd Aldermanic District**

**W. Florist Ave. – N. 68th St. to N. 76th St. (ST211070124):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (0-7 foot width of tree border area), and grading.

Ald. Donovan moves approval with late billing. Prevailed 4-0. (Ald. Wade excused.)

**3rd Aldermanic District**

**E. Back Bay – A point east of N. Terrace Ave. to N. Terrace Ave. (ST211110128):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (1-7 foot width of tree border area), and grading.
