Dear Council Members:

Enclosed please find a proposed resolution approving payment of \$222,846.29 and \$24,514.44, to settle the claim of Terry Davis, Jr., arising from a motor vehicle accident on December 13, 2022.


Mr. Davis, Jr., was struck by a City of Milwaukee Department of Public Works vehicle. Mr. Davis, Jr., sustained significant, permanent injuries. The claimant submitted an itemized statement of damages requesting \$1,246,872.00, in total damages including \$248,042.28 in medical bills on August 1, 2024.

This matter has been fully investigated. Based on the status of this claim, it is the City Attorney's recommendation that the proposed settlement is in the City's best interest.

We request his matter be assigned for hearing in an open session before the Judiciary and Legislation Committee in order to act.
