DETAILED DESCRIPTION OF INCIDENT:

While driving south on Teutonia, my front left tire on the driver's side blew out after striking an unmarked island-cement block at the intersection of Roosevelt and Teutonia. I immediately contacted my emergency service. I, also, sent my daughter, friend and exchange student to investigate what object I hit. They informed me it was an unmarked cement block/island. Prior to the emergency service arriving at the scene, a Cadillac also driving south on Teutonia struck the same Island and blew out their front and rear tires on the driver's side. This occurred approximately at around 9pm. I then called 911 to request officer assistance and the nature of the accidents. While having my tire changed by the emergency service, 2 small vehicles driving south on Teutonia hit the same obstruction in the road and blew out their front left tires. I once again contacted 911 for assistance between 945 and 10pm. Jasmine's aunt, Patricia Ward, picked up Jasmine at the site and confirmed the unmarked island and witnessed the last two vehicles hitting the island and damaging their vehicles.

On July 26, 2001, I contacted DPW and the city to report the hazard and to file a claim.


