Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

The following items are related to the license business at 4402 W. Center Street, Jay's Food.

- 1. On 03/09/24 at 7:21 p.m., Officers were dispatched to a Threat complaint. A group of males were loitering in the business parking lot. When the agent confronted the subjects asking them to leave, one subject threatened to shoot the agent. All of the subjects were gone prior to officer's arrival.

This license premise report is submitted by P.O. Daryal GOSS assigned to District Seven, Late Power Shift.

On Saturday, March 9th, 2024, I was assigned to Squad 7440 with P.O. Andres MEXICANO.

At approximately 7:21 p.m., we responded to the address of 4402 W. Center Street for a Threat complaint. This address is located in the City and County of Milwaukee, WI. For this report, it should be noted that this address is "Jays Food," a licensed City of Milwaukee establishment.

Upon arrival, we spoke to the cashier, who identified himself verbally as Ahmad H ISSA (unknown/male, 09/04/04). ISSA stated that he was the 911 caller. ISSA reported that at approximately 7:10 p.m. on Saturday, March 9th, 2024, he confronted a group of male subjects who were loitering in the parking lot of the establishment. ISSA stated that he asked the subjects to leave, and that is when one of the male subjects threatened to shoot him. ISSA stated that he immediately returned inside the store and called the police. ISSA did not see a firearm. ISSA stated that after he called the police, all of the subjects walked away in an unknown direction. ISSA described the subject that threatened him as a B/M teenager, approximately 6'1, light complexion, last seen wearing a grey and black camo hooded sweatshirt, black pants, and white Air Force Nike shoes.

On Friday, January 17th, 2025, at approximately 7:12PM, squad 7451 (PO Andres MEXICANO and I) were dispatched to an entry into a business call for service at 4402 W Center St, Jay's Food Groceries and Tobacco, which is located in the City and County of Milwaukee.

Upon arrival I made contact with the store clerk, who was verbally identified as Ahmad H ISSA (W/M 09/04/2004). ISSA stated that at approximately 3:14AM on 01/17/25, his employer's business alarm went off due to an unknown subject breaking in. ISSA stated the subject stole cash and merchandise from the business. ISSA stated that the subject took approximately \$5,000 in cash, which was kept in two unlocked cash registers and underneath the cashier counter. ISSA stated the subject also took 26 full cartons of Newport cigarettes, which were valued at \$2,834, and were kept behind the cash register in an unlocked cabinet. ISSA stated the subject took approximately 10 boxes of vapes, which were valued at \$100, and were kept in a case on the west side of the store.

ISSA was very cooperative with police. The premise did have a valid license for food dealer retail and cigarette and tobacco sale. Both licenses expire on 06/10/2025.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
