4. On 04/22/19 at 5:18pm, Milwaukee Police were dispatched to 8200 W. Brown Deer Road for an accident complaint. Investigation revealed that a vehicle struck the west side of the filling station and fled the scene. The employee gave the police the license plate number of the striking vehicle as well as the surveillance video.

5. On 08/14/19 at 10:47pm, Milwaukee Police were dispatched to 8200 W. Brown Deer Road for a trouble with subject complaint. Upon police arrival, there was no issue of trouble so the caller was contacted who stated that he was at the filling station earlier in the evening and was approached by a panhandler. The caller also observed several other customers being approached by panhandlers and wanted to bring this to the attention of the police.

- 6. On 01/30/23 at 11:18p.m., officers were dispatched to an Armed Robbery at 8200 W. Brown Deer Rd. Officers interviewed the caller/employee who stated a suspect was shoplifting and when confronted, pulled a gun on the caller. Further investigation and upon viewing video surveillance of the incident, this was deemed to be unfounded and baseless. The suspect was in a verbal argument with the caller and their son, and was later arrested for Disorderly Conduct While Armed.
- 7. On 02/07/23 at 8:26a.m., officers were dispatched to Reckless Use of A Weapon at 8200 W. Brown Deer Rd. Officers interviewed the caller/employee who stated a subject entered the store and attempted to purchase a Black and Mild Cigar. When the employee requested to see Identification the customer became upset, exited the store, at which time the employee heard approximately 3 gunshots. Security on scene advised the employee their personal vehicle was shot into.

- 8. On 02/28/23 at 1:04pm, Milwaukee Police were dispatched to 8200 W. Brown Deer Rd, for a trouble with subject. Officers were sent regarding a panhandler outside the business refusing to leave. Officers checked the surrounding area for subject and did not locate the subject. The caller was advised to call if the subject returns and the issue persists.
- 9. On 03/05/23 at 5:10am, Milwaukee Police were dispatched to 8200 W. Brown Deer Rd, for a trouble with subject. Officers spoke with the employee who stated that a subject was acting erratic and refusing to leave. The subject was in the store and was blocking the entrance/exit door to the business. The subject was advised if he returned he would be cited and left the location without further incident.

Officers spoke with caller who stated that his vehicle was stolen while it was parked at the gas pumps. Officers spoke with the employee who stated that the camera system was not operating properly. Officers reviewed video at the business and it corroborated the employee's statements to police.

The employee stated that a subject was in the location selling unknown items for a book bag to random customers at the location. The employee told the subject to leave, but the subject refused. Prior to police arrival the subject fled the area on foot. The business was cooperative with police and provided video.
- 18. On 02/24/2024 at 5:00 AM., officers were dispatched to 8200 W. Brown Deer Rd., Andy's, for a Theft complaint. A subject entered the business, stole candy, but came back to return the item. No additional police enforcement was needed.

At approximately 5:33 AM., a customer leaves their vehicle running near the pumps and walks into the business. An unknown actor enters the customer's vehicle and drives away. - 21. On 04/29/2024 at 10:30 PM., an officer was dispatched to 8200 W. Brown Deer Rd., Andy's, for a Welfare check. The victims and suspect met in the parking lot where a domestic altercation took place. The suspect damaged a victim's car and displayed a handgun. Victims were not cooperative in the investigation. Employees did not

- witness the incident, but security cameras captured the incident. No license violations were observed.
- 22. On 05/20/2024 at 7:09 PM., Milwaukee Police received a call for a Theft complaint at 8200 W. Brown Deer Rd., Andy's. A group of kids entered the business and stole several items.
- 23. On 09/08/2024 at 8:00 AM., Milwaukee Police received a call for a Theft complaint at 8200 W. Brown Deer Rd., Andy's. Several subjects entered the business and stole items. No license violations were observed.
- 24.On 11/14/2024 at 6:30 PM., an officer conducted follow-up regarding a shooting investigation at 8200 W. Brown Deer Rd., Andy's. The officer was allowed access the security camera system, which was new and in working condition. The business was cooperative.

On Saturday March 30, 2024, at approximately 6:14am while in full duty uniform equipped with an axon body camera activated and in marked squad my partner PO Eugene REESE and I were dispatched to 8200 W Brown Deer Rd which is located in the City and County of Milwaukee, State of Wisconsin for a motor vehicle theft complaint.

Upon arrival, I spoke with the victim/caller who was verbally identified as Jimmy Q. HUBBARD (B/M 01/16/1994) who stated that on today's date he parked his vehicle at Andy's Gas Station around 5:30am. HUBBARD exited the vehicle and left the vehicle running with the keys/fob still in the vehicle. At approximately 5:33am a silver Hyundai vehicle entered the parking lot. An unknown actor who was wearing a black Nike sweatshirt and black sweatpants exited the vehicle and got into HUBBARD'S vehicle and fled the gas station headed Eastbound. HUBBARD stated that the only thing of value he had in the car was a pair of \$3000.00 Cartier Sunglasses. HUBBARD has no insurance on the vehicle.

Officers spoke to a license premise employee of the gas station who was verbally identified as Rufai O. SALAMI (B/M 06/04/1981) who stated he was working at the time of the incident. SALAMI did not witness the incident when it occurred, but the gas station has video surveillance footage that showed the incident. Video surveillance footage was observed on scene by officers.

I reviewed video surveillance footage. The footage showed at approximately 5:30am the victim/caller who was identified on scene as Jimmy Q HUBBARD (B/M 01/16/1993) parking his vehicle and exiting while leaving it running. Approximately 3 minutes later a silver Hyundai vehicle enters the parking lot and parks directly behind HUBBARD's vehicle. The driver of the Hyundai exits his vehicle and gets into HUBBARD'S. A passenger in the Hyundai gets into the driver's seat and both cars leave the scene heading east bound on W Brown Deer Rd. The video was recovered via Flash Drive and will be inventoried/uploaded to AXON.

While on scene, I observed the licenses posted and they were up to date. During my investigation of the motor vehicle theft, I did not observe any violations in the licensed premise.

On Sunday, March 31st, 2024, at approximately, I was dispatched to 8200 W Brown Deer Rd for a Battery/Fight/Assault Complaint.

Upon my arrival, I observed Frankie DAY (B/M 07/12/1984) who stated that he got into it with a woman named JALISA. DAY refused to give officers her last name. DAY stated he didn't know if he was scratched or cut with a knife on his elbow by JALISA. Officers asked DAY if he needed medical and he denied it. DAY stated he didn't want to press charges on JALISA. DAY stated he wasn't scared of JALISA or didn't fear for his safety. Officers asked Day multiple times if he was scared or fearful for his safety, he denied it every time.

I spoke to licensed premise employee, Rufai Salami (m/b 06-08-81). They stated that a male had come inside to ask to call the police. The business was cooperative with the investigation. The business had no security officers on the scene.

I reviewed video surveillance footage. The footage showed the vehicle pull in and DAY and JALISA seemed to be upset at each other. JALISA appeared that she didn't want DAY inside the vehicle and was trying to force him out. JALISA appeared to push and swipe at DAY it's unknown if JALISA had a weapon or she was just using her nails. The action continued for 20-30 minutes until DAY backed away from the vehicle and JALISA returned to the vehicle and fled the location going north from the parking lot, then DAY walked into the business. The employee did show the video to officers upon request.

While on the scene, I observed the licenses posted and they were up to date. During my investigation, I did not observe any violations in the licensed premises.

This report is submitted by Police Officer Shane Bishop assigned to District Four, Late Power Shift, Squad 4431 with Police Officer Ashley Pashkewitz.

On Monday, April 29th, 2024, at 10:30pm, Squad 4431 was dispatched to a "Welfare Check" and "Call for Police" at the location of 8254 West Brown Deer Road. The female caller stated she was 16 years of age and people were chasing her. The female then stated she was at a gas station and ran out of gas. A call back and the female stated she was at a gas station and arguing was heard in the background with another unknown female telling the caller to "Get off the Phone with the Police". This is related to Milwaukee Police Department CAD (Computer Aided Dispatch # P2404291508 and originated at 10:24pm. Squad 4431 is familiar with the Andys Gas Station located at 8200 West Brown Deer Road which is located extremely close to this dispatched assignment.

On arrival, at the gas station, nobody initially approached officers or flagged down officers. I parked along the west side of the gas station and was preparing to exit the squad vehicle to make contact with the cashier that was working in the gas station to see if he witnessed anything when a blue in color Nissan Sentra arrived at the gas station from unknown direction and parked near Squad 4431's squad vehicle. I immediately noticed that the rear window of the vehicle was missing and appeared to have been damaged. Police Officer Pashkewitz made contact with the occupants of the vehicle initially and I observed there to be three females inside the vehicle. All three females began to talk quickly, and Police Officer Pashkewitz asked a female in the rear seat to step out so she could speak with her separately. This female initially made a claim of battery to officers and Police Officer Pashkewitz attempted to speak with this female further however the female became uncooperative.

I asked the female seated in the driver seat to exit the vehicle and speak with me near the nearby Squad vehicle. The female agreed and verbally identified herself as Jeanice SU Ford b/f 08-23-2004. Ford stated she is the owner of the vehicle. The vehicle is a 2018 Nissan Sentra 4door with Wisconsin registration plate AVP-6590, vin # 3N1AB7AP0JY214337. Ford stated the female in the rear seat of the vehicle is her cousin and provided the first name "Aleria". A records check revealed and confirmed Ford to be the registered owner of the vehicle.

Regarding this incident, Ford stated there was a previous altercation between "Aleria" and her child's father she only knows as "Kewane". Ford stated this incident occurred on West Atkinson Avenue near North 22nd Street but a specific time or address was not provided. Ford stated that during this incident, "Aleria" was battered by the male "Kewane" and he had struck her several times. Ford stated that the male had also taken a cell phone during this incident, and he had accidently taken her cell phone. Communication between "Aleria" and "Kewane" continued, and he agreed to return the phone to the

females at the gas station located at 8200 West Brown Deer Road. It should be noted that "Aleria" refused to make a statement about this event to Police Officer Pashkewitz.

Ford stated they drove to the gas station, and she physically pointed out to me that she had parked facing west near the middle pumps; specifically Pump #10. Ford stated that the male "Kewane" had arrived on scene and was armed with a gun and threw a "brick" through her rear window. Ford stated that the male didn't say anything to her directly during this incident. Ford stated she then left the location and was followed by the male. I asked Ford what type of gun the male had possessed, and she stated she didn't know. Ford stated that the male did have a handgun and it was either silver or gray in color. Ford stated she doesn't have insurance for her vehicle and estimated the value of the rear damaged window of her vehicle to be \$400.00. I asked Ford what the male looked like and she went to her vehicle to look for a photograph of the male on a social media post. I observed the male to be a black male, mid 20's, slim build, approximately 5'09", with short dreads style hair, and tattoos on his face and hands. No further information was provided. While onscene, the other females inside the vehicle claimed that the same male had just drove by and waved a gun out of the window. When asked what type of vehicle the male was in the females stated a gray Ford 4door with no plates and a white in color Infiniti with a dealer plate. I asked specifically which vehicle the male was in, and they stated "both" and that there were multiple people in the vehicles. The females inside the vehicle became angry at Police Officer Pashkewitz for trying to obtain a statement. The subject in the rear seat, "Aleria" actually refused to provide her date of birth or make further statement and rolled her window up. The females stated that they wanted to go to the suspect's residence with police which we advised would not happen as they had claimed he was armed with a firearm.

Damage to the window was recorded via officer's body worn video camera. The females in the vehicle demanded that officers check the area for the suspect immediately. Squad 4431 checked the area for the suspect / suspect vehicles but were not able to locate him at this time.

Onscene, I later made contact with the gas station employee, verbally identified as Paa K Seidu b/m 04 -17-1994. Seidu had started his shift at 10:00pm and didn't witness this incident. Seidu did allow officers access to the business' security video system. The business does have both numerous interior and exterior cameras. I observed Camera #4 and Camera #11 to be exterior cameras which are elevated on the building and face to the west which faces the gas pumps and surrounding parking lot.

After video review, I observed that this incident was indeed captured on the gas station video camera system and the incident was specifically captured on Camera #11. The video camera system does have correct date and time and the time is displayed as military style time. I observed the following:

- 22:19 Ford is observed driving her vehicle onto the Andy's Gas Station parking lot from West Brown Deer Road. Ford drives to Pump 15 and parks. No subjects exit the vehicle.
- 22:23 A gray in color Ford 4door sedan is observed entering the parking lot and backs into parking space near an air pump at the far west border of the gas station. A white in color 4 door medium sized SUV is also observed arriving in the parking lot and also parking at the far west border of the gas station parking lot.

- 22:23 - A male is observed exiting the gray in color sedan's front passenger door and jogs over to Ford's vehicle from the southwest. The male quickly points towards the vehicle and then kicks the front driver window twice with his right foot. Ford begins to drive away from the pump to the south back towards West Brown Deer Road. As Ford drives past the male he appears to throw an unknown object at the rear window of Ford's vehicle causing damage.

The suspect appears to be a black male, slim build, wearing a red in color baseball style hat, a red and white jacket, gray pants and white shoes. From the video it is unclear if the male is in possession of a firearm.

- 22:24 - The male returns to the gray in color Ford and enters the vehicle. The gray in color vehicle and white in color Infiniti are observed leaving the gas station parking lot to the south towards West Brown Deer Road.

Officers were not able to obtain the video at this time. Employee Seidu was very cooperative with officers in assisting in this investigation. Per District Four protocol, a license premise report to also be filed.

I then observed that all camera boxes on the monitor were active and showed footage which was different then in 2022 when there was cameras which were inactive. Camera # 4 still was pointed at the gas pumps. Camera # 8 was still pointed at the cashier's counter. Camera #10 was still pointed at the NB Exit. And Camera #11 pointed at the parking lot. While on scene I counted at least three different types of camera as well as two cameras disconnected and sitting on the table in front of the surveillance monitor, and a different make and model sitting on the floor just inside a vestibule door was.
