This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/12/2019 at 8:53pm officers conducted a license premise check at Rose's Place, 2878 N. 20th St. The officer attempted to open the door and found it locked. He pressed the doorbell next to the door and the bartender buzzed him in. The bartender showed the officers the business licenses and his Class D Operator's license. The bartender stated the business would be open on New Year's Eve with three bartenders. The officer advised to call the police if any problems occur. The officers advised the bartender that the agent would have to explain why the doors are locked.
2. On 03/17/2020 at 8:20pm officers conducted a license premise check at Rose's Place, 2878 N. 20th St. The officer found the bar to be closed in compliance with the Governor's order.
3. On 04/17/2020 at 1:05am officers observed four subjects exiting Rose's Place, 2878 N. 20th St. The officers then conducted a license premise check. The front door was locked but a subject, who identified himself as the manager, opened the door. The manager stated there was only himself and one other subject cleaning the business. He did later admit that there were people in the bar. The officers advised him the business does not have a food license and is considered nonessential, so it must be closed by the current order issued by the Governor.

4. On 12/31/20 at 9:50pm, Milwaukee Police conducted a license premise check at 2878 N. 20th Street. Officers found during the interaction that the establishment had been serving food without a food license. The bartender and applicant (who was notified by telephone) were advised not to serve food without the proper license. The bartender said that he would comply.
5. On 06/19/21, Milwaukee Police were dispatched to a shooting at 2878 N. 20th Street. Investigation revealed that a large fight erupted outside, in front of the tavern. The operator of the establishment observed the fight and tried to break it up only to be shot by an unknown subject. The operator then received a ride to the hospital where it was found that another person was also shot during the incident. Officers observed that there are surveillance cameras outside the establishment that would have captured the incident but it was found that the system was unplugged and not working.
6. On 06/27/21 at 9:35pm, Milwaukee Police conducted a license premise check at 2878 N. 20th Street. Upon arrival, officers had to ring a doorbell to gain entrance into the tavern because the door was locked. The person in the tavern opened the door for officers and said the tavern was closed and that the bar manager would be in later to open the establishment. While talking to the employee, officers observed a case of 20ml liquor bottles on the bar which showed it was purchased at a public liquor store. The employee was informed that all liquor had to be purchased from a distributor and he told officers that they get their liquor from Badger Distributing. When asked about to operator who was shot on 06/19/21, the employee said that he was at home recovering and that the manager who was coming in tonight was covering for him. Officers observed that the surveillance system was operational but did not record. The officers informed the employee of the parking issues caused by the tavern and said that they would try to make it back to inform the new manager of their issues.
7. On 07/10/21 at 10:17pm, Milwaukee Police observed the vehicle owned by the operator of the establishment at 4001 W. North Avenue parked out front. Wanting to talk with the operator about the shooting on 06/19/21, officers decided to enter the tavern. Officers found a single patron inside with a beer and the employee from item #6 who had a valid bartenders license.

This Report is written by PO Russell MACRAE - LATE POWER TAVERN CAR.

On 12/31/2020 at 09:50pm, PO David LETTEER and I (SQ#5468) along with PO Adam MARITATO and PO Robert PARKS (SQ#5469) conducted a Tavern Check at ROSE'S PLACE located at 2878 N 20th Street. Upon arrival, I observed (3) patrons inside sitting at the bar. We made contact with the bartender identified by WI-DL as Dwayne HARDWICK (B/M 01/12/61). We informed HARWICK that we were conducting a routine license check of the tavern.

Upon walking around the premise, we observed food serving supplies on a table in the backroom near the pool tables. The table had food trays along with buffet serving supplies. It appeared that all of the food supplies, trays had been used in the recent past. They were not actively cooking or serving any food.

A license check in LIRA revealed that the tavern did NOT have a Food Dealer license. We informed HARWICK that if this continued that the tavern would receive a citation for not having the proper food licenses. HARDWICK stated that he understood and that he would not serve any food moving forward without a license. We informed HARDWICK that we would be contacting the Licensee Patricia PICKENS regarding.

License Premise Report

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 06-26-21 I (PO LETTEER) was informed that there was a shooting located at 2878 N. 20th St., which is Rose's Place, 06-19-21. Rose's Place is a licensed tavern in the city of Milwaukee. I checked to find out if a license premise report had been filed by the officers on scene, but I was unable to locate a report.

On 06-19-21 officers were sent to the tavern, in which the callers father had been shot. Upon arrival, officers were able to enter the tavern. The located blood on the steps of the bar, which led down the steps, onto the city sidewalk and south from the bar on the N. 20th St. (city sidewalk). Officers followed the blood trail, but it abruptly stopped, leading officers to believe the shooting victim entered a vehicle and left the scene. As the investigation continued, officers were notified that there were two shooting victims at Mt. Sinai Hospital. One victim with a gun shot to the left leg and another with a gun shot wound to the chest, which was later changed to a gunshot wound to the left forearm. The victim that was shot to the leg was the current bartender at Rose's Place, Dwyane HARDWICK (SR) (b/m 01-12-61).

Detectives spoke to HARDWICK at the hospital and HARDWICK stated that he went to his bar Rose's Lounge located at 2878 N 20th St, to close it down for the night. HARDWICK explained that the owner of the bar is "Patricia Picken" who resides above the bar, but he operates it.

HARDWICK stated when he pulled up to the lounge, he observed approximately 10-20 black male subjects engaged in a physical altercation directly in front of the lounge. HARDWICK said it appeared as if one of the subjects was being jumped by the others. When he got closer to the crowd, HARDWICK exclaimed "We don't do that here" while simultaneously grabbing one male subject away from the fight. HARDWICK said as he was pushing the male subject he had away from the crowd, he immediately heard one gunshot and instantly fell to the ground. HARDWICK said he didn't see who was shooting.

HARDWICK stated during the shooting, he was in possession of his firearm, which he described as an all-black 9mm Taurus. HARDWICK said his gun was not used during the shooting and he did not shoot himself. HARDWICK said he knew he was going to the hospital, so he contacted his goddaughter BROOKS, Waynisha K (F/B, 05/21/97), and gave it to her. Detectives were able to recover HARDWICK's firearm and place it on inventory, so that the firearm could be ruled out as being used during this incident.

It should be noted that when PO MACRAE and I visit the tavern and HARDWICK is there, he does have his firearm with him in order to protect the business.

Detectives were able to speak to witnesses that stated there were numerous people outside of the tavern who were involved in an argument that led to a physical fight near the front entrance.

Another witness stated there were people outside of the bar who began to argue and fight. The bartenders then began to shut the bar down and tell people to leave the tavern.

The witnesses did not see anyone shot.

While onscene, officers observed cameras around the exterior of the bar. Officers inquired with staff if the cameras were working. They were informed that the cameras were not working. Upon further investigation regarding the cameras, it was found that the camera system was unplugged, thus the cameras did not capture this incident.

On 06-27-21 I attempted to contact the listed agent, Patricia PICKENS, in order to inquire about the camera system and inform her that I was filing this report. The male who answered the telephone told me to call back tomorrow morning and that PICKENS was not available.

The last time PO MACRAE and I were at the establishment, we informed HARDWICK that if he was doing day to day operations of the tavern, that he needed to apply for his Class B Managers license. Upon looking at LIRA, HARDWICK only has a Class D Operator's license (BART 233850) which is set to expire 12-31-21. There is no application for a Class B Managers license.

License Premise Report

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 06-27-21 at 9:35 p.m., we conducted a license premise check of Rose's Place, which is a licensed tavern in the city of Milwaukee. Upon our arrival, the interior lights were turned on, as well as the neon window lights, which led us to believe that the tavern was open for business. We were conducting follow up regarding a shooting that occurred at the bar on 06-19-21 (IR 21-178-0177).

As we approached the front door or main entrance, I attempted to open the door, but found that it was locked. There is a doorbell that I had to use to get the attention of an employee inside of the establishment. I rang the doorbell and observed a black male inside of the establishment, walk from the bar area to an area that out of sight of the front door, a back room. I rang the doorbell once again and observed the black male walk out front the backroom and come to open the door for us.

We entered the establishment and there were no patrons inside of the bar. It did appear that there may be a party that may be occurring at the bar. The pool table and other tables had white sheets or coverings, along with other decorations. The black male, identified as William PHILLIPS (b/m 09-29-71) who stated the bar was not open for business, but that he was at the bar cleaning. PHILLIPS stated that the bar might be open later in the night.

PHILLIPS stated all he was doing was cleaning and that the bar manager, whom he identified as Vanessa, would most likely be at the bar when it opened. I inquired if he knew if Vanessa had a Class D or Class B license and he stated he believed that Vanessa had her licenses and that bar would not open unless she was there.

As I was speaking to PHILLIPS, PO MACRAE observed sitting on the bar was an unopened box of 200ml bottles of Hennessy. PO MACRAE inspected the box and found that there was a label that showed that the box was purchased from Colberts Beer and Liquor Mart, located at 1737 W. Hampton Ave. PO MACRAE informed PHILLIPS that any liquor that is sold at a licensed establishment had to be purchased through a distributor. PHILLIPS stated the bar buys all of its liquor through Badger Distributors. PO MACRAE also informed PHILLIPS that the 200ml bottles of Hennessy are in demand right now at the bars and again informed him that the box that was on the bar could not be sold at the bar.

PO MACRAE conducted a quick inspection of the tavern. While he was doing this, I inquired about the camera system. I observed that the monitor that displays the camera videos was turned on and was

showing all the camera angles. While asking PHILLIPS about this, he was using his phone and it appeared that he was watching the cameras and what PO MACRAE was doing on his phone. I asked PHILLIPS if the cameras record and he stated that at this time they do not record.

We asked if HARDWICK, the bartender who was injured during the shooting incident, was coming back to the bar, but we were informed that he is at home recovering from his gunshot wound. PHILLIPS stated that Vanessa would be at the bar, in his place. PHILLIPS stated PICKENS was the agent, but that she is still having health problems. We inquired on who is doing the day to day operations and ordering of liquor at the tavern. PHILLIPS stated that HARDWICK is doing the purchasing of liquor for the tavern. PHILLIPS stated that he is just an employee and helps out at the bar. A check of PHILLIPS on LIRA revealed that he does not have any City of Milwaukee alcohol related licenses.

While there, we addressed other issues at the bar, such as parking on N. 20th St. and W. Locust St. PHILLIPS stated the bar was trying to help with the parking problems, by putting no parking signs on the north side of W. Locust St. and that the bar was trying to keep people from parking on the corners of the street, so that no patrons vehicles would be struck by other vehicles. PHILLIPS also stated that if there are any problems at the bar, it is always outside. PHILLIPS stated that the bar checks people and that they keep everything in the bar controlled, but if something happens, it will be outside of the bar.

We informed PHILLIPS that we would be back at the bar, in order to speak with Vanessa and check to see if she does have her Class D or Class B license. We left our contact card with PHILLIPS and informed him to let PICKENS know that we would be filing our tavern reports.

We were never able to return to the tavern, due to other calls for service that we were dispatched to.

This report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468 Tavern Car.

On 07-10-21 we drove by the licensed tavern, Rose's Place and found that a vehicle belonging to the normal bartender Mr. HARDWICK, was parked in front of the tavern. We had believed that Mr. HARDWICK had returned to bartend at the bar and that he was there. I wanted to speak to Mr. HARDWICK regarding being shot at the bar.

We entered the tavern and found one patron inside of the bar, with a beer and his credit card on the bar. The only other person in the bar was William PHILLIPS (b/m 09-29-71). In our previous tavern check of the tavern, Mr. PHILLIPS did not have a Class D or Class B license.

I asked PHILLIPS if he had a bartender's license and he produced a Class D Operator's license (Bart 237452), which is valid from 07-07-21 and is set to expire on 12-31-22.

We thanked Mr. PHILLIPS for acquiring his license and informed him that a license report would be filed. We then left the tavern.
