1st Aldermanic District

W. Custer Ave. – N. 33rd St. to N. 35th St. (ST211050121):

Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

3rd Aldermanic District

N. Pulaski St. – N. Arlington Pl. to E. Kane Pl. (ST211030112):

Colored concrete reconstruction, replace all sidewalk and driveway approaches with colored concrete, special treatment, and sodding.

5th Aldermanic District

N. 80th St. – W. Keefe Ave. to W. Nash St. (ST211050119):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, and sodding.

7th Aldermanic District

N. 39th St. – W. Ruby St. to W. Hampton Ave. (ST211050111):

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

8th Aldermanic District

W. Canal St. – Miller Park Ring Road to Falk Dr. (SW170050101):

Install sanitary sewer.

W. Canal St. – Miller Park Ring Road to Falk Dr. (SW170050112):

Install storm sewer.

W. Canal St. (South Stadium Access Rd.) – Miller Park Ring Road to S. 44th St. (WT410051093):

Install water main

W. Canal St. – S. 30th St. to S. 44th St. (WT410031068):

Install water main.

W. Falk Dr. – 1000 feet m/l northeast of W. Canal St. to W. Canal St. (WT410051092):

Install water main.

S. 37th St. – W. Burnham St. to W. Mitchell St. (ST211050116):

Asphalt pavement resurfacing, replace all curb and gutter sidewalk and driveway approaches, sodding, and tree removal where necessary.

8th and 11th Aldermanic Districts

W. Forest Home Ave. – S. 35th St. to S. 42nd St. (ST30683601):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

10th Aldermanic District

Alley between W. Center St., W. Hadley St., N. Lefebber Ave., and N. 72nd St. (ST212050147):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

12th and 14th Aldermanic District

S. 6th St. – S. Chase Ave. to W. Maple St. (ST320030101):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

14th Aldermanic District

Alley between E. Euclid Ave., S. Hanson Ave., S. Nevada St., and E. Oklahoma Ave. (ST212050109):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

15th Aldermanic District

N. 13th St. – W. Meinecke Ave. to W. Clarke St. (ST211050110):

Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

N. 37th St. – W. Meinecke Ave. to W. Clarke St. (ST211050113):

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

**Alley between W. Meinecke Ave., W. North Ave., N. 35th St., and N. 36th St.
(East-West Leg and a portion of the North-South Leg) (ST2112050141):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.
