Re: Report on the Extended Hours Establishment renewal application of Amjad T. Tufail, agent for Shan Food Sales, Inc., for the premises located at 4806 West Lisbon Avenue in the City and County of Milwaukee, Wisconsin ("Judy's Red Hots").

FINDINGS OF FACT

1. Amjad T. Tufail (hereinafter the "licensee"), agent for Shan Food Sales, Inc., holds an Extended Hours Establishment license for the premises located at 4806 West Lisbon Avenue in the City and County of Milwaukee, Wisconsin ("Judy's Red Hots"). Said license expires at midnight, April 30, 2012.

- 2. An application to renew said license was filed with the Office of the City Clerk on February 13, 2012.
- 3. Pursuant to Section 84-7 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation and the police department responded with a police report dated February 15, 2012.
- 4. On March 14, 2012, the City Clerk's Office provided timely notice to the licensee, pursuant to Section 84-7 of the license renewal haring and police report. The matter was scheduled for a hearing on the police report on March 26, 2012 at 9:00 a.m. in Room 301B of the third floor of City Hall. At said date, time, and place, the licensee did appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On October 2, 2010 at 2:27a.m., Milwaukee police responded to a fight complaint at 4806 West Lisbon Avenue (Judy's Red Hots). The manager of the business told police a fight erupted in the lobby of the business at approximately 2:30 a.m. The fight consisted of 25-30 people and spilled out into the parking lot of

the business. Shortly after police arrived, the fighting ceased and people began to leave.

B. On July 16, 2011 at 2:51a.m., Milwaukee police were on patrol when they observed several people and vehicles loitering in the parking lot at 4806 West Lisbon Avenue ("Judy's Red Hots"). In addition to people standing in the lot, there were two women dancing on the top of a car in the parking lot. An officer exited his squad car and began to walk towards the dancing women. At this point, he observed that the car was a late model, silver Chevrolet Impala four-door, or similar vehicle. By this time, both females observed police and ceased their actions. A man who was part of a group standing next to the Impala, then walked to the Impala and got into the driver's seat. The officer attempted to initiate contact with the driver as another officer stood by as cover. Just then, a black vehicle, occupied by two black males drove into the parking lot, stopping in front of the Impala, so the passenger side of the black car was facing the front of the Impala. A hand reached out of the passenger side of the black car, holding a pistol. An officer was about ten to twelve feet away from the man with the gun at that point. The man stared firing approximately eight to ten shots of rapid fire at the Impala. Several people that were standing in the lot then began to run in the opposite direction of the gunfire. Officers attempted to stop occupants of the black car as it left the parking lot, when an officer observed that a gun was in the hand of the driver of the black car, with the gun muzzle pointed in their direction. An officer discharged one time at the driver of the black auto. The black auto then fled north on North 48th Street. It is unknown if the black auto or the occupants of it were struck.

> It was later determined that a citizen was struck once in the face by gunfire from the black car. The victim was taken to St. Josephs Hospital by private vehicle and subsequently transported to Froedtert Hospital. The surveillance system at the business was functioning and did capture this incident. Milwaukee police were able to retrieve video from the business. An incident report was filed.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Section 84-7 of the Milwaukee Code of Ordinances.
- Based upon the above facts found, the Committee concludes that the licensee, Amjad T. Tufail, agent for Shan Food Sales, Inc., who holds an Extended Hours Establishment license for the premises located at 4806 West Lisbon Avenue in the City and County of Milwaukee, Wisconsin

("Judy's Red Hots) has not met the criteria of Section 84-7 of the Milwaukee Code of Ordinances to allow renewal of the Extended Hours Establishment license because of the police report. The Licenses Committee finds the police report, as stated above, to be true.

3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Extended Hours Establishment license held by Amjad T. Tufail, agent for Shan Food Sales, Inc., for the premises located at 4806 West Lisbon Avenue in the City and County of Milwaukee, Wisconsin ("Judy's Red Hots") because of the above findings of fact.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and zero (0) noes, recommends that the Extended Hours Establishment license held by Amjad T. Tufail, agent for Shan Food Sales, Inc., for the premises located at 4806 West Lisbon Avenue in the City and County of Milwaukee, Wisconsin ("Judy's Red Hots") not be renewed based upon the police report.

FINDINGS OF FACT

1. Robert S. Hrenak (hereinafter the "licensee") holds a Junk Collector (Truck) license for the premises located at 2128-B W. National Avenue in the City and County of Milwaukee, Wisconsin ("Roberts Towing"). Said license expires at midnight, April 30, 2012.

2. An application to renew said license was untimely filed with the Office of the City Clerk on January 30, 2012.

Pursuant to Chapter 92 of the Milwaukee Code of Ordinances the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report dated January 31, 2012, which could form the basis for denial or suspension of this license.

4. On March 14, 2012, the City Clerk's Office provided notice to the licensee, pursuant to Chapter 92 of the Milwaukee Code of Ordinances of the police report that could be the basis of non-renewal or suspension of this license as well as of the neighborhood objections that could form the basis for suspension or non-renewal of the license of the licensee. The licensee was provided a copy of the police report with the notice of hearing. The matter was scheduled for a hearing on the neighborhood objections on March 26, 2012 at 9:15 a.m. The licensee did not

appear at hearing on two occasions and he was not represented by counsel.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing was sent to Robert S. Hrenak at P.O. Box 100581, Cudahy, Wisconsin 53110 on March 14, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of P.O. Box 100581, Cudahy, Wisconsin 53110 is the address given by the licensee on his application. The envelope was returned to the License Division by the United States Postal Service.

A notice of the hearing was sent to Robert S. Hrenak at 2128-B West National Avenue, Milwaukee, Wisconsin 53204 and 5023 South Nicholson Avenue, Cudahy, Wisconsin 53110 on March 14, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The addresses of 2128-B West National Avenue, Milwaukee, Wisconsin 53204 and 5023 South Nicholson Avenue, Cudahy, Wisconsin 53110 are the addresses given by the licensee on his application. The envelopes were not returned to the License Division by the United States Postal Service. The licensee failed to appear at two hearings following proper notice and mailing by United States first-class prepaid mail.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 92 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee has not met the criteria of Chapter 92 of the Milwaukee Code of Ordinances to allow renewal of his Junk Collector (Truck) license based upon two nonappearances.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Junk Collector (Truck) license of Robert S. Hrenak for the premises

located at 2128-B W. National Avenue in the City and County of Milwaukee, Wisconsin ("Roberts Towing") based upon two nonappearances.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Junk Collector (Truck) license of Robert S. FINDINGS OF FACT

1. Belinda R. Sims (hereinafter the "licensee"), agent for S&S Auto Sales, LLC, holds a Secondhand Motor Vehicle Dealer's license for the premises located at 5211 West Lisbon Avenue in the City and County of Milwaukee, Wisconsin ("S&S Auto Sales LLC"). Said license expired at midnight, March 31, 2011.

2. An application to renew said license was untimely filed with the Office of the February 1, 2012.

3. Pursuant to Chapter 92 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department and Department of Neighborhood Services (DNS) for investigation. The DNS responded with information that could form the basis for denial or suspension of this license.

4. On March 14, 2012, the City Clerk's Office provided notice to the licensee, pursuant to Chapter 92 of the Milwaukee Code of Ordinances of the DNS report that could be the basis of non-renewal or suspension of this license as well as of the neighborhood objections that could form the basis for suspension or non-renewal of the license of the licensee. The licensee was provided a copy of the DNS report with the notice of hearing. The matter was scheduled for a hearing on the neighborhood objections

- on March 23, 2012 at 9:45 a.m. The licensee failed to appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing was sent to Belinda R. Sims, at 5211 West Lisbon Avenue, Milwaukee, Wisconsin 53210 on March 14, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 5211 West Lisbon Avenue, Milwaukee, Wisconsin 53210 is the address given by the licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on March 26, 2012 following proper notice and mailing by United States first-class prepaid mail.
 - B. Todd Vandre of the Department of Neighborhood Services (DNS) testified that the applicant was illegally storing cars at the site and that the applicant's occupancy permit allows for auto sales only. Mr. Vandre also testified that DNS issued a revocation order on March 13, 2012 and that the applicant missed his appeal on the revocation order. Mr. Vandre stated that the occupancy permit issued to the applicant was conditional based on the applicant getting the proper licenses and that the applicant does not hold valid state and city dealer licenses.
 - C. Alderman Michael Murphy also objected to renewal of the license based upon the DNS testimony.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 92 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Belinda R. Sims, agent for S&S Auto Sales, LLC, has not met the criteria of Chapter 92 of the Milwaukee Code of Ordinances to allow renewal of the Secondhand Motor Vehicle Dealer's license for the premises located at 5211 West Lisbon Avenue ("S&S Auto Sales LLC") based upon nonappearance, DNS objection, and aldermanic objection.

FINDINGS OF FACT

1. Amritdeep Kaur (hereinafter the "licensee"), agent for Shubh Alliance, Inc., holds an Extended Hours Establishment license for the premises located at 714 North 27th Street in the City and County of Milwaukee, Wisconsin ("Mobil Gas Station"). Said license expires at midnight, April 30, 2012.

2. An application to renew said license was filed with the Office of the City Clerk on February 28, 2012.

Pursuant to Section 84-7 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation and the police department responded with a police report dated February 29, 2012.

On March 15, 2012, the City Clerk's Office provided timely notice to the licensee, pursuant to Section 84-7 of the license renewal hearing and police report. The matter was scheduled for a hearing on the police report on March 26, 2012 at 2:45 p.m. in Room 301B of the third floor of City Hall. At said date, time, and place, the licensee did appear and was represented by Attorney Vincent Bobot.

Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. On November 30, 2011, between the hours of 12:00 a.m. and 2:00 a.m. and 7:00 p.m. and 9:00 p.m., Milwaukee police were conducting surveillance at the Mobile Gas station at 714 North 27th Street due to a high volume of subjects loitering, drug related activity, vehicles with loud music violations and other quality of life issues. Officers observed in that time frame, numerous subjects loitering outside the gas station even though No Loitering signs were posted. Officers observed

numerous municipal violations these subjects were violating who were cited. Violations observed were loitering, aggressive pan handling and public urinating.

- B. On December 6, 2011 at 1:35 a.m., Milwaukee police were conducting surveillance at the Mobile Gas station at 714 North 27th Street due to a high volume of subjects loitering, drug related activity, vehicles with loud music violations and other quality of life issues. Officers observed a subject walk onto the gas station lot and stand outside the front door. The subject was also observed to be drinking what appeared to be a fermented malt beverage as another subject joined her with a beer in his hand. Field interviews were conducted and citations for public drinking were issued.
- C. On December 12, 2011, between the hours of 12:00 a.m. and 2:00 a.m., Milwaukee police were conducting surveillance at the Mobile Gas station at 714 North 27th Street due to a high volume of subjects loitering, drug related activity, vehicles with loud music violations and other quality of life issues. Officers observed in that time frame, two subjects urinate on the side of the gas station with both being cited for disorderly conduct. Later that night at 11:30 pm, Milwaukee police investigated a complaint made by the clerk of the gas station. Security officer Tracey Underwood was holding a subject who was demanding that the clerk give her four dollars that he owed her. The clerk refused and told the woman to leave. The woman left, but returned shortly after and began kicking and thrashing herself around the store causing damage. The security guard "bear hugged" her and held her down until police arrived. Officers observed broken glasses of juice and salsa on the floor as well as food products. The subject was arrested and conveyed to the station for processing.
- D. Alderman Bauman testified that there has been a consistent pattern of problems at the gas station as indicated by the police response reports in the record. He added that the committee recommended nonrenewal of previous licenses and that the license was suspended at least three times in the past. One was a 2006 suspension by the Common Council, which was reduced from a nonrenewal recommendation by the committee. Alderman Bauman testified that he was opposed based upon consistent crime and disorder at the gas station, PA-33s, the police report, police observations and testimony, and Ms. Byrd's testimony.
- E. Officer Lesniewski of District 3 testified on behalf of the captain in opposition based upon the amount of police resources used for the gas station for all hours of the day, including the hours between midnight and 5:00 a.m.
- F. Officer Gryzkewicz of District 3 testified that she does the late shift between the hours of 7:00 p.m. and 3:00 a.m. For surveillance shifts and other occasions of the last calendar year, she said that she personally witnessed, between the hours of midnight and 3:00 a.m., loitering, panhandling, and public drinking of alcohol. She said that she observed

and issued a citation for public drinking of alcohol on December 6, 2011 at 1:35 a.m. She added that she did observe security or management from the gas station attempt to remove loiterers a few times but not enough. She said that many people walk, congregate, and drink alcohol publicly in the area in general as well during these hours; however, the gas station is the only business remaining open after midnight in the area. During the period of when the license was suspended for twenty days last year, she said that she did not observe any of these issues.

- G. Officer Schultz of District 3 testified to personally witnessing loitering, panhandling, disorderly behavior, and urination during one surveillance operation that he took part of within the last calendar year between midnight and 5:00 a.m. He added that loitering took place in the general area as well.
- H. Officer Hopgood of District 3 testified that he does the late shift between the hours of 9:00 p.m. and 5:00 a.m. and has seen the same issues as the other officers who had testified before him. Between midnight to 5:00 a.m., he said that he personally witnessed urination and public drinking of alcohol. During the last three months, he added that he has witnessed known prostitutes frequenting the gas station parking lot and in the general neighborhood area.
- I. Ms. Marilyn Byrd of 3102 West McKinley Boulevard testified as to personally witnessing the presence of many people at the gas station between 10:00 p.m. and 3:00 a.m. during a night that she and her church did evangelizing at the bus stop next to the gas station parking lot.
- J. The licensee, Ms. Kaur, testified that during her one year and four months tenure as the licensee, the station has no loitering signs in the front and eight security cameras. She said that the station does not sell any alcohol. She added that loiterers return to the station during the extended hours despite her attempts to remove them from the premises.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Section 84-7 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Amritdeep Kaur, who holds an Extended Hours Establishment license for the premises at 714 North 27th Street in the City and County of Milwaukee, Wisconsin ("Mobil Gas Station") has not met the criteria of Section 84-7 of the Milwaukee Code of Ordinances to allow renewal of the Extended Hours Establishment license because of the police report, police testimony, aldermanic objections, and neighborhood objections. The Licenses Committee finds the police report, police testimony, aldermanic objections and neighborhood objections, as stated above, to be true.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of

Milwaukee it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Extended Hours Establishment license held by Amritdeep Kaur, agent for Shubh Alliance, Inc., for the premises at 714 North 27th Street in the City and County of Milwaukee, Wisconsin ("Mobil Gas Station") because of the police report, police testimony, aldermanic objections and neighborhood objections.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes, and one (1) abstention, recommends that the Extended Hours Establishment license held by Amritdeep Kaur, agent for Shubh Alliance, Inc., for the premises at 714 North 27th Street in the City and County of Milwaukee, Wisconsin ("Mobil Gas Station") not be renewed based upon the police report, police testimony, aldermanic objections, and neighborhood objections.
