

Description of File:

It is a Facebook flyer for an upcoming event at the Lounge 340 on March 10th. It states the event requires patrons to bring containers of any size to the bar to receive alcoholic beverages. Cups are specifically not allowed. This type of event underlines the existing complaint signed by over 30 nearby residents of their concern for the amount of inappropriate activity that is caused by the bar. Even if this event that will potentially lead to overserving is legal, it is more appropriate for a college bar located on a main commercial strip or near a stadium center... not a small residential neighborhood bar.

Good Evening Officer BruLo,

I went to the station today and received your contact information from Officer Po Spence.

I am writing to you in regards to an establishment called Lounge 340 that I'd like to make a request to be checked on by the District 5 tavern car. At the intersection of Vel. R Phillips Ave and W Reservoir Ave, it is a small bar/lounge located within a developing residential neighborhood bordering MLK drive.

As a current resident living near Lounge 340, I have deep concerns and frustrations with how this bar impacts the neighborhood. Similar concerns are shared among many of my neighbors (many have moved away due to this place.) This has been an ongoing issue since they reopened after COVID lockdowns in 2020.

To give you an idea, please see the below list of offenses that myself and many of my neighbors have witnessed first hand with description. I've also attached photo and video documentation of some of these offenses. I've described what can be seen in these.

**Public Intoxication** - Patrons whether arriving, attending, or leaving will often roam the streets around the building, sometimes blocking traffic. Patrons often exhibit signs of intoxication (yelling, words slurred, stumbling, obliviousness to passing traffic and have open containers.

**Loitering** - Sometimes this bar seems more like a public gathering ground than a private business. Large groups will form outside, often carrying alcohol outside of the club or beverages brought with them (we know they bring outside drinks since we often find entire bottles in the bushes outside of neighboring properties). Sometimes people that don't even enter the club come by just to hang out. Often times patrons will stay long after the club has closed. Club security makes no effort to disperse individuals.

**Illegal Parking** - This bar does not have a parking lot, therefore street parking is the only option. Cars are lined up for blocks, often times they will block sidewalks or even resort to sitting in the middle of the street for 5-10 mins to talk to people outside of the vehicles.

**Vehicle Noise** - Subwoofers, loud music, you name it. Often patrons will sit 10-20 mins in their cars before entering the club, or they will sit in park before leaving the area. Often times cars will drive by the club to stop to blare their systems to get a rise out of the outside gathering crowd.

**Outside Liquor** - As previously stated, patrons often will bring outside liquor to consume outside of the club. This is confirmed with finding anything from beer cans to entire bottles of Hennessy stowed away in the bushes near where patrons had previously parked.

**Drug Dealing** - I've only witnessed this directly once. After a massive July 2nd party, the club had been closed for hours, yet cars returned and remained parked blocking the street while small bags and cash were exchanged. I'm aware the club can't control this, but thought I'd toss this in the report.

**Obstructing Traffic** - Cars of I assume friends of patrons outside the club will often stop and block the entire streets. Cars will also be illegally parked too close to the corners which creates dangerous situations for vehicles and intoxicated pedestrians trying to cross.

**Extensive Littering** - In the bar's license, they state they are responsible for picking up trash left by patrons. They state this is done daily and weekly. This is far from the case. Often times myself and my neighbors will go out and clean up discarded trash. Trash ranges from discarded plastic cups/straws from the club to shattered glass bottles from outside supply.



**Evidence:** \*please note this is only a minor sample of my own collection. I have far longer videos and my neighbors have their own collections.

**I've also attached a link to a Google Doc that has my entire collection of videos and pictures of incidents leading back to November. These contain videos too big to send via Gmail.**

**File A** - This was taken last week (8/12). As you can see, a car is parked in the middle of an intersection. Crowds gather with some still holding cups from the club. You should also note, when the club is officially open, they have a bright red neon "Open" sign above their front door. This is turned off, indicating the club had closed. This demonstrates a common issue where patrons still loiter around the premises even after the club has long closed. The bar owners and bouncer never make an effort to disperse crowds despite it stating they are responsible to do so in their license.

**File B** - This was taken this evening. More crowds outside. Tricycle bikes blocking roads. They also sat around for about 10 mins blaring excessive music to the point where my [redacted] and I had to shout at each other [redacted] despite standing 3 feet away from each other. I can provide the video in a later email, I can't send in this one due to gmail size restriction.

**File C** - Doesn't look like much is happening here, except for the fact that the club despite not having licensed outdoor seating still provided a group of individuals with a makeshift card table in order to drink outside on the sidewalk. This group eventually swelled to about 20 people.

**File D** - This was from a large day time party this previous July 2nd. Eventually this party would build up to be the worst incident we've seen so far this year. Crowds as large as 80 people outside at times. Eventually a large brawl broke out in the intersection which involved almost pulling a handgun. The club actually closed relatively earlier due to it being a day party, but crowds still remained gathered well past midnight. This further demonstrates the use of outside alcohol. I have this incident on video, but once again I can't attach due to size limitations of email. We can view this in further discussion

**File E** - This is the morning after the July 2nd incident. This is after my [redacted] and I had gone out and hand picked up all trash leftover from the night prior. We intentionally dump the garbage we find on their front doorstep hoping to send a message.

**File F** - This was taken last Thursday. A group of patrons left the club and continued to loiter outside. They stood outside yelling and proceeded to open up a champagne bottle and drink from it (public drinking, loitering, and once again bringing outside alcohol). Notice to the left of the picture, the bouncer is sitting on the steps oblivious to patrons loitering. This underlines a common issue.

I think this file just goes to show how the club has no control over their patrons...

This video is from the July 2nd fight. You hear a woman yelling to put away the gun. My [redacted] also caught this same fight on video. It is unknown if the gun was drawn and aimed at someone or if someone had just taken it out to deter the fight.

**Lounge 340 Bar License** - A copy of their bar license. In the document it states they are responsible for crowd control, litter pick up, and also state the bar never gets excessively packed. We witness these agreements broken multiple times per week.

I should also note that calling the non-emergency police phone for this district has not effective. In the last 4 months my [redacted] and I have probably called at least a dozen times and an officer is not dispatched to check the situation. If the police do arrive, it is far after the club has closed. The one time they showed up on time, they didn't make any effort to talk to the bar owners or security and left the scene.

**PLEASE NOTE ON BAR HOURS:** While their license says they are open 6am to 2am 7 days a week, this club is not open consistently. Some weeks they will open Thurs-Saturday nights. Other weeks they'll be open on Tuesday night and another week they will only open on a Friday night from 8pm-midnight. You can't accurately predict when this bar opens. You might have to call the owner's cell number retrieved from their license, [redacted]

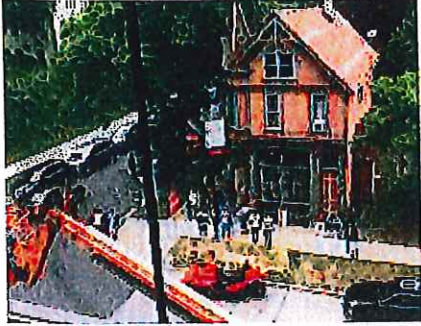
