Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/21/23 at 4:06p.m. officers were dispatched to a Theft at 3725 S. Howell Av. Officers were advised by the caller/employee a theft had occurred, however, were not able to get into the video surveillance system. The employee further stated they did not want a citation issued for the incident. The employee was cooperative.

2. On 06/11/23 at 9:26pm, Milwaukee Police were dispatched to 3725 S. Howell Avenue for a threat compliant. Investigation revealed that a subject entered the store and tried to walk out the front entrance without paying for product. When the clerk told him to pay for the items or he will call police, the subject threated bodily harm on the employee. Call for Service -

On Sunday, June 11, 2023, at 9:21 PM, I (Squad 6290 - in full duty uniform, operating a marked Milwaukee Police Department wagon, equipped with an activated AXON body camera) was dispatched to 3725 S. Howell AV. (BP Gas Station) in the city and county of Milwaukee, Wisconsin, in regard to a threat call for service.

On Scene/License Premise -

Upon arrival at the listed location at 9:26 PM, I was met by caller/later identified as gas station employee; Salman AHMAD (A/M, 08-02-1995) who stated on today's date (06-11-2023) at 9:20 PM, an unknown suspect with the following description; B/M, (Unknown height and weight), wearing a red hooded sweatshirt, blue jean pants or shorts, with black Adidas shoes and long socks, entered the store and began to pick up a case of energy drinks. AHMAD stated the subject then began to walk towards the exit doors without paying for the items he had in his hand. AHMAD stated he told the subject that he would call for emergency police services if he did not pay for the items. AHMAD stated the subject them dropped the items onto the ground and became aggressively argumentative with him stating that he would cause bodily harm to him if he called for police. AHMAD stated he then called for police assistance and the unknown subject walked out of the store in an unknown direction on foot.

I advised AHMAD that I would need to complete a License Premise report, AHMAD provided me with the following information.

When asked for video surveillance of the incident, AHMAD stated he does not have access to the video system and stated the subject did not remove any items from the store after he called for police but stated he did not want to press charges for the threats, he just requested police because he did not want the incident to escalate.

I observed video surveillance cameras in the interior of the building but did not observe video surveillance cameras on the exterior. There were no security guards on the property and no guards inside the store.

Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
